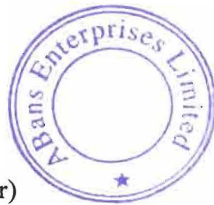

Summary of Proceeding of the 35th Annual General Meeting (AGM) of Abans Enterprises Limited

The 35th Annual General Meeting (AGM) of the Members of the Company was held on Wednesday, September 29, 2021 at 01.00 P.M. through Video Conference (VC) / Other Audio Visual Means (OAVM). 26 (Twenty Six) Members were present in persons / through authorized representative at the above meeting.

Mr. Abhishek Bansal, Chairman and Managing Director chaired the Meeting and welcomed other Directors and the Members to the meeting. Chairman of the meeting was assisted by Mr. Shobhan Mandulla, Company Secretary. The requisite quorum being present, the Chairman called the meeting to order and transact the business as per notice of AGM. Further Necessary statutory documents, registers and reports were made accessible to the members, electronically.

The Chairman informed that in view of the restrictions due to outbreak of COVID-19 and considering the social distancing norms, the AGM was conducted through VC / OAVM. This meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). The Chairman informed that the Company had tied up with National Securities Depositories Limited (NSDL) to provide facility for voting through remote e-voting, e-voting during the AGM and participation in the AGM through VC / OAVM facility through RTA.

The Chairman informed the members that the report of board of directors, the accounts for the financial year ended 31st March, 2021 and the notice convening the 35th AGM were taken as read as the same had already been circulated to the members. As there were no qualifications in the Audit Report, it was not required to be read. The Chairman started the proceedings of meeting by briefing about financial and operational performance of the Company during F.Y. 2020-21.

The Chairman informed the Members that the facility of remote e-voting for the Members was made available from Sunday, September 26, 2021 (9:00A.M.) till Tuesday, September 28, 2021 (upto 5:00 P.M.) and that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.

The Chairman further informed that Mr. S. P. Date, Practicing Company Secretary (Membership No. A2018) was the Scrutinizer appointed by the Board to scrutinize the remote e-voting and e-voting at the AGM. 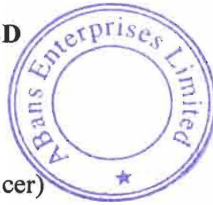
