Request for Name Correction of 1st Allottee

At allotment, the 1st allottee was known as Anthony P C or P C Anthony. Thus his account in Maharashtra State Co-operative Bank is in the name of Anthony P C and Gas connection is in the name of P C Anthony. However, Anthony P C / P C Anthony was expanded into Anthony Chakkappan Puthusseril in the Pass Port. The name change was also notified in Maharashtra Gazette and notarised. As a matter of, Anthony P C / P C Anthony are names in short whereas Anthony Chakkappan Puthusseril is the full name. These names belong to one and the same individual and are often interchanged. For example, there is an ICICI Bank joint account in the name of P C Anthony and another joint account, in the name of Anthony Chakkappan Puthusseril.

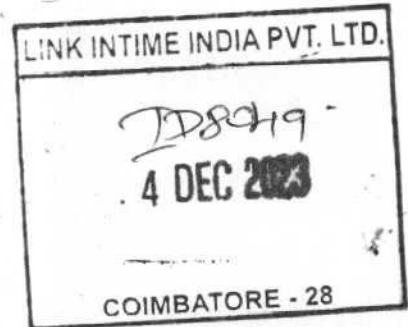
