'Milk' oya Milk

...the first notification (FANI) issued by the Ministry of Road Transport and Highways (MoRTH) in 2015, which was aimed at protecting the interests of the dairy industry producing plant-based milk and cheese. The term milk has been used to refer to both dairy and non-dairy milk in India since ancient times, she said in a statement.

She said that the definition of milk has been disputed between the dairy and non-dairy producers and makers, such as almond, soy and rice-based milk. Dairy companies argue the label with dairy products as milk is misleading, while non-dairy companies argue it is misleading to consumers into buying nutritional products.

Ms. Singhal said the notification was prepared after extensive research. "It's not possible for us to react to a viewpoint. The notification is for seeking comments for 30 days, which it will be sent to a scientific committee for comments," Singhal told ET.

MoRTH's website says it has 160 members and over 200 supporter organisations across the country. It has raised concerns on behalf of industries, farmers and stakeholders who will be affected by the notification. The letter to the MoRTH chief said consumers allergic to dairy products have choices in plant-based milk options such as almond, soy and rice milk, and that "excluding the term milk from plant-based products does not serve any purpose".

She said the MoRTH Annual India's Largest TV Advertiser, and MoRTH's objection was against certain industry lobbies. "Headed by the MoRTH, the national food regulator is both consumer friendly and farmer friendly and aligns with international standards of dairy-based products."
