Plea to deploy Army in Manipur: SC says will never direct the forces

Asks parties to come up with other constructive suggestions

New Delhi, July 12

THE SUPREME COURT on Tuesday refused to accede to a request to direct the Army and paramilitary forces regarding security deployments in strife-torn Manipur, with Chief Justice of India D Y Chandrachud remarking that civilian control over the armed forces is one of the hallmarks of democracy and the court will never breach that.

On Monday, the SC had asked the parties in the matter to come up with constructive suggestions it can consider. On Tuesday, senior advocate Colin Gonsalves, representing some tribal groups from the state, sought to draw the attention of the bench, also comprising Justices P S Narasimha and Manoj Mishra, to what he claimed was one-sided attacks on people belonging to tribal communities.

Taking exception, the CJ said, "This can't be the tenor of suggestions. For instance, you are asking the court to direct the Indian Army and paramilitary to take particular steps. Frankly... in the last over 70 years, the Supreme Court has not given directions to the armed forces... One of the great hallmarks of democracy (is) civilian control over the armed force. Let's not breach that. That's one of the strong points of this nation. We will not do that. We are not going to issue directions to the Army."

Later, the bench said this in

its order: "Petitioner seeks intervention of the court in the form of direction to Army and paramilitary forces to take such steps as are necessary to provide security in the villages (to come under further attacks)... Maintenance of law and order (and) preservation of security of the state are essentially matters which fall in the executive domain. We are of the view that it would not be appropriate for this court in the exercise of its power of judicial review to issue specific directions in regard to the deployment of Army or paramilitary forces, which must be left to the state administration and the Union of India to oversee."

The court also referred to what the Manipur Chief Secretary said about deployment of security forces in the latest status report filed by the state.

The court asked both the Centre and the state government to "make sufficient arrangements to ensure protection of lives and property of all citizens and residents of Manipur".

The CJ then remarked orally that for the court to get into "where exactly a battalion should be deployed... is very dangerous". He observed, "We are... monitoring the situation. If it becomes necessary for us to pass some calibrated orders beyond what we have done, we will not fight shy of doing it, conscious as we are of the remit of judicial review".

Solicitor General Tushar Mehta protested some of Gonsalves's submissions that accused the Centre and the state government. Intervening, the bench told Gonsalves, "These are allegations... It's a fact for you. It's a matter of investigation eventually. The moment you say certain terrorist organisations are aligned with and protected by the state and Central governments, the SG is not going to accept and we will not be able to make any headway".

The court asked Mehta to look into some of the suggestions put forth by advocate Mohammed Nizam Pasha, and take "positive action" on or before Friday".

Bengal rural poll violence: Death toll rises to 45

CM says saddened by the loss of lives in sporadic violence

IN CONTINUING VIOLENCE in West Bengal, where at least 39 have died in the run-up to the panchayat elections and during polling, six more persons were killed in clashes during counting on Tuesday night. This takes the total toll to 45 since polls were announced on June 8.

Three persons, including two activists of the Indian Secular Front (ISF), were killed near a counting centre in Bhargar in South 24 Parganas district, which saw some of the worst violence in the last one month. Police said the clash broke out when

ISF supporters hurled bombs outside the counting centre in Bhargar late on Tuesday night.

"Around midnight, some people started a commotion

outside the counting centre at Bhargar. They hurled bombs, aiming at our colleagues. In retaliation and to maintain law and order, our officers carried out a lath-

charge. The police personnel had to fire a few rounds of teargas and rubber bullets after the situation started deteriorating," a police officer told PTI.

The ISF supporters who died have been identified as Rezaul Gazi and Hasan Mollah, the third victim has been identified as Raju Mollah.

Meanwhile, West Bengal Chief Minister Mamata Banerjee on Wednesday said she is saddened at the loss of lives in "sporadic" incidents of violence during rural polls. She also asserted that her government has given a free hand to the police to take action against those behind the violence.

"I am saddened at the loss of lives in sporadic incidents of violence during panchayat elections... The polls were held in 71,000 booths, but incidents of violence took

place in not more than 60 booths," she said.

The chief minister claimed that 19 people, mostly from the TMC, died in poll-related violence since the election date was announced on June 8. "I am giving free hand to the police to act against those behind the violence," she told reporters.

The ruling TMC is set for a sweeping victory, bagging more than half the seats and leaving its rivals trailing way behind in results declared till now by the State Election Commission.

The election was held on July 8 in over 61,000 booths, with a voter turnout of 80.71 per cent. West Bengal has 3,317 gram panchayats with 63,229 seats, 341 panchayat samitis with 9,730 seats, and 20 zilla parishads with 928 seats.

Rallying behind Rahul: Cong stages 'maun satyagrah'

THE CONGRESS ON Wednesday staged a nationwide 'maun satyagrah' to protest Rahul Gandhi's disqualification from Parliament and asserted that no one can silence him or the party. The former Congress chief was disqualified from Lok Sabha on March 24 after a Surat court convicted him in a 2019 defamation case over his "Modi surname" remarks. He represented Kerala's Wayanad in the Lower House of Parliament. The party had said it will move the SC after the Gujarat High Court refused to stay Gandhi's conviction. Congress general secretary in-charge organisation KC Venugopal said the party held the nationwide 'maun satyagrah' opposing the disqualification of Gandhi. — PTI

Oppn meet in Bengaluru: Leaders of 24 parties invited, Sonia Gandhi to attend

THE OPPOSITION GROUPING to take on BJP in the next Lok Sabha polls is set to expand with more parties joining in at the second unity meeting being convened by the Congress next week in Bengaluru.

Leaders of 24 non-BJP parties have been invited for the meet on June 17 and 18, the first edition of which saw the participation of 15 parties.

Congress Parliamentary Party chairperson Sonia Gandhi is also expected to attend a dinner meeting on July 17, where leaders of these parties will be present.

There will be more structured formal meeting the



next day, where the Opposition front would further strategise its plans to take on the BJP in the next Lok Sabha polls.

Sources said the MDMK, KDMK, VCK, RSP, Forward Bloc, IUML, Kerala Congress (Joseph) and Kerala Congress (Mani) are among political parties that will join the sec-

ond Opposition meeting.

A senior Opposition leader said he has received the invite from the Congress president to attend the dinner meeting, followed by a formal meeting the next day.

The 24 opposition parties have together around 150 Lok Sabha members currently and are seeking to expand their base. The parties are likely to deliberate on a broad plan for their unity efforts, where they intend to put up one common candidate against the BJP across the country, sources said.

The first such meeting of opposition parties was held in Bihar's Patna on June 23. Sixteen parties were invited for the Patna event, of which 15 had attended. RLD's Jayant

Chaudhary could not attend due to a family function.

The Aam Aadmi Party has also been invited for the Bengaluru meeting. The Kejriwal-led party had asked the Congress to make its stand clear on the Delhi ordinance before the next meeting. The AAP had said that if the Congress did not publicly support it on the Ordinance issue, it would not attend the next meeting.

Karnataka Deputy Chief Minister D K Shivakumar had said that Sonia Gandhi would be attending the meeting.

While announcing the dates of the meeting, Congress general secretary (organisation) K C Venugopal had said: "We are steadfast in our unwavering resolve to defeat the fascist and undemocratic forces."

SC stays NGT order asking L-G to head panel for Yamuna

THE SUPREME COURT Tuesday stayed the National Green Tribunal's January 9 direction appointing Delhi Lieutenant Governor as the chairman of a high-level committee on Yamuna rejuvenation.

"There shall be a stay of the operation of the direction issued on 9 January 2023 by the National Green Tribunal to the extent that the Lieutenant Governor has been directed to be a member of the committee and to chair it. The rest of the committee shall continue to function", ordered

a three-judge bench presided by Chief Justice of India D Y Chandrachud.

The bench, also comprising Justices P S Narasimha and Manoj Mishra, issued notice on the Delhi government's plea challenging the NGT order.

The NGT had constituted the high-level committee of authorities concerned in Delhi, where pollution in Yamuna

is higher (about 75%) compared to other river basin states, and said, "We request Lieutenant Governor... who is chairman of DDA and administrator of Delhi under Article 239 of the Constitution, to head the committee."

Ajit Pawar, Praful Patel in Delhi to meet Amit Shah

AMIDA STANDOFF over allocation of portfolios in Maharashtra, senior NCP leaders Ajit Pawar and Praful Patel arrived here on Wednesday evening for a meeting with Union Home Minister Amit Shah and top BJP leaders.

Talking to reporters, Patel, the working president of the Nationalist Congress Party, dismissed suggestions about a rift in the ruling BJP-Shiv Sena-NCP alliance in Maharashtra and asserted that the issue about the allocation of portfolios has been sorted out and will be allocated in a day or two. In a surprise development on July 2, the Sharda Pawar-led NCP split as his nephew Ajit Pawar and almost three dozen MLAs joined the ruling Shiv Sena-BJP alliance. Ajit Pawar and eight other NCP leaders were sworn in as ministers. "Do not read too much into our meetings here. It is just a courtesy call as senior BJP leaders. Ajit dada and myself have not had a formal meeting with the top BJP leadership. We will be meeting Home Minister Amit Shah and other BJP leaders here," Patel said. — PTI
