Sub: E-voting facility, fixation of Cut-off date and Book closure for Dividend and Annual General Meeting (AGM).

Dear Sir/Ma'am.

This is in continuation to our letter dated July 12th, 2023 regarding "Outcome of Board meeting", we wish to inform you that the 37th Annual General Meeting (AGM) of the Company is scheduled to be held on Wednesday, August 23rd, 2023 at 11:00 A.M. at the registered office of the Company i.e. at Village Somalheri/Lehli, P.O Dappar, Tehsil Derabassi, Distt. Mohali, Punjab.

In compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations 2015 (SEBI (LODR) Regulations, 2015), the Company will provide evoting facility (remote e-voting facility) to its members as an alternate mode to exercise their right to vote on the resolutions proposed to be passed at the 37th AGM of the Company. The facility for casting the votes by the members using an electronic voting system from a place other than venue of the AGM ("remote e-voting") will be provided by Link Intime India Pvt. Ltd. (LIIPL).

Further, the Company has fixed August 16th, 2023 as the cut-off date to ascertain the eligibility of the members of the Company for entitlement to dividend and to cast their votes through remote e-voting as well as for the voting/polling at the 37th AGM of the Company.

Therefore, a person, whose name is recorded in the registers of members of the Company or in the register of beneficial owners maintained by the depositories as on the cut-off date, only shall be entitled to received dividend for FY 2022-23 and to avail the facility of remote e-voting (including voting at the AGM).

The remote e-voting period begins on August 20th, 2023 at 9:00 a.m. and will end on August 22, 2023 at 5:00 p.m.

The Register of Members & Share Transfer Books of the Company will remain closed from August 17, 2023 to August 23rd, 2023 (both days inclusive) for the purpose of Dividend and AGM to be held on August 23rd, 2023.
