Members may note that the NINETEENTH (19th) ANNUAL GENERAL MEETING ("AGM") of ROUTE MOBILE LIMITED ("COMPANY") will be held on September 22, 2023 AT 3:30 P.M. (IST) through Video Conferencing ("VC")/Other Audio-Visual Means ("OAVM") in compliance with all the applicable provisions of Companies Act, 2013 (the "Act") and the Rules made thereunder and SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 read with applicable General Circular No. 10/2022 dated December 28, 2022 in relation to "Clarification of holding of Annual General Meeting ("AGM") through video conferencing ("VC") or other audio visual means ("OAVM") [(read with Ministry's General Circular No. 2/2022 dated May 5, 2022, 20/2020 dated May 5, 2020] (hereinafter referred to as "MCA Circular") and Securities and Exchange Board of India ("SEBI") vide its Circular No. SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated January 5, 2023 in relation to "Relaxation from compliance with certain provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Reg." (hereinafter referred to as "SEBI Circular") (read with other SEBI circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022) (together referred to as "Applicable Circulars") to transact the business that will be set forth in the Notice of the AGM. Members can attend & vote in the AGM only through VC/OAVM facility. National Securities Depository Limited ("NSDL") will be providing facility for voting through remote e-Voting, for participation in the AGM through VC/OAVM facility and e-Voting during the AGM. Members participating through VC/OAVM facility shall be deemed to be present at the AGM and their presence shall be reckoned for the purpose of quorum.

1. **Dispatch of Annual Report:** In compliance with the MCA Circulars and SEBI Circulars, Notice of the 19th AGM along with the Annual Report for Financial Year 2022-23 will be sent only through electronic mode (by e-mail) to those Members whose e-mail addresses are registered with the Company / Depository Participant(s) ("DPs"). As per the Applicable Circulars, no physical copies of the Notice of the 19th AGM and Annual Report for FY 2022-23 will be sent to any Shareholder, though the copies of the Notice of the 19th AGM along with Annual Report for the FY 2022-23 shall be sent to those Members who request for the same. A copy of Notice of the 19th AGM along with the Annual Report for Financial Year 2022-23 will also be available on the Company's website at <https://routeonline.com/investors>, websites of the Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com respectively, and on the website of NSDL at <https://www.evoting.nsdl.com>. The instructions for joining the AGM will be provided in the Notice of the AGM.

2. **Manner of casting vote(s) through e-voting:** Members will have an opportunity to cast their vote remotely or during the AGM on the businesses as set forth in the Notice of the 19th AGM through the electronic voting system ("e-voting"). The manner of voting remotely ("remote e-voting") or during the AGM will be provided in the Notice convening the AGM. The facility for voting through electronic system will also be made available at the AGM and the Members attending the AGM through VC/OAVM facility who have not cast their votes through remote e-voting, and are otherwise not barred from doing so shall be eligible through e-voting system in the AGM. Members are requested to read and understand all the "Notes" forming part of the Notice convening AGM particularly those dealing with manner of casting vote through remote e-voting or during the AGM. The login credentials for casting votes through e-voting shall be made available to the Members through email. Members who do not receive email or whose email addresses are not registered with the Company/ Registrar and Transfer Agent ("RTA") i.e. KFin Technologies Limited ("KFinTech")/DPs, may generate login credentials by following instructions given in the "Notes" forming part of the Notice convening the AGM. The login credentials as aforesaid may also be used for attending the AGM through VC/OAVM facility. 3. **Dividend:** Members may note that the Board, at its meeting held on May 19, 2023, has recommended a final dividend of ₹ 2 (rupees two) per equity share of ₹ 10 (rupees ten) each (20%) for the financial year ended March 31, 2023, subject to the approval of the shareholders/Members at the ensuing AGM. The Dividend if approved at the AGM, will be paid within 30 days of the AGM. The Company has fixed September 6, 2023 as the "Record Date" for determining entitlement of Members to dividend. For Members who are unable to receive the dividend directly in their bank accounts through ECS or any other means, due to non-registration of the Electronic Bank Mandate, the Company shall dispatch the dividend warrant/demand draft to such Members, through postal or courier services at their registered address.

4. **TDS on Dividend:** Pursuant to the Finance Act, 2020, dividend income is taxable in the hands of shareholders with effect from April 1, 2020 and the Company is required to deduct tax at source from dividend paid to shareholders at the prescribed rates. For the prescribed rates for various categories, the shareholders are requested to refer to the Finance Act, 2020 and amendments thereof.
