## Western disturbances using foggy winter, says IMD

New Delhi, 18 January

The India Meteorological Department (IMD) today said that the very dense fog and severe winter prevailing since December 25 over the entire northern plains starting Amritsar to Dibrugarh across Haryana, Delhi, UP and Bihar can be

attributed due to lack of active western disturbance due to El Nino.

It also said that strong jet streams are also causing the cold conditions.

"Generally, 5-7 western disturbances (WDs) impact Northwest India during December to January. But this winter no such western disturbance has been received. Two affected the country this year,

one in December and another in January but their impact was mainly confined to Gujarat, north Maharashtra, East Rajasthan and Madhya Pradesh. As a result, Western Himalayan Region has received very less precipitation (rain or snow) during the month of December which is roughly about 80 per cent less than normal over the region," the IMD:
