

As regard to Deferred Tax as per Ind AS-12 on "Income Taxes", there is a net deferred tax asset for the past years amounting to Approx. Rs.1869.26 Lacs. As evidenced by the current year (FY 2018-19) financials, there is a swift turnaround in the "pipes" segment. The management is seriously contemplating the certainty and sustainability for the above said turnaround in the future, based on future profits projection being prepared, considering the business climate, orders on hand, tenders being filled, future capex, outcome of the ongoing central elections, past experience etc. Pending the above, as matter of prudence, the company has not recognised the said deferred tax asset. 3. in view of thrust by the Central/State Governments on execution of various infrastructure projects, Company expects a robust revenue visibility in the 'PIPES' segment. Current order book is good. 4. Previous year/quarter figures have been regrouped/rearranged wherever considered necessary. 5. The figures of the quarter ended March 31 2019 are the balancing figures between audited figures in respect of the full period of twelve months ending as at March 31, 2019 and the unaudited published year to date figures upto December 31, 2018, being the date of the end of the third quarter of the Financial Year. 6.
