We shall intimate the revised date of Board Meeting in due course of time.

Further, in terms of the provisions of Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, the trading window of the Company which was closed from the end of the previous quarter i.e. with effect from 1st April, 2020 will continue to remain close till Forty-Eight (48) hours from the announcement of first Quarter Results (Quarter ending June 2020 of FY 2020-2021) by the company to the stock exchanges ,where the shares of the company are listed.
