Congress demands to suspend Ranveer Allahabadi, Samay Raina's YouTube channels

Mumbai, Feb 13 (UNI) : Maharashtra Congress on Thursday demanded to permanently suspend podcaster Ranveer Allahabadi, comedian Samay Raina's YouTube channels after they made obscene content and broadcasted it on Raina's India's Got Latent show after it sparked a huge controversy.

In a letter to Minister for Information & Broadcasting and a complaint lodge with the Resident Grievance Officer, Rakesh Shetty, spokesperson of Maharashtra Congress, demanded immediate removal of all objectionable content from YouTube and permanently suspend Ranveer Allahabadi and Samay Raina's YouTube channels. He also

demanding imposition of a strict strike under YouTube's enforcement policy.

With a subscriber base of 23 million, their content is being widely imitated by minors and young audiences, leading to severe moral and ethical concerns. This content promotes indecency, explicit language, and unethical behaviour, directly contradicting YouTube's policies against harmful and inappropriate content, he said. Shetty also criticised Prime Minister Narendra Modi for honouring Allahabadi, who boasts over six lakh followers on X, 4.5 million on Instagram, and more than one crore subscribers on YouTube, with a "National Creators Award" presented to him before the 2024 Lok Sabha elections.

PM Modi meets with Tesla chief Elon Musk at Blair House

Washington/New Delhi, Feb 13 (UNI) : Prime Minister Narendra Modi today met with Tesla chief Elon Musk at Blair House. According to visuals, the multi-billionaire US businessman and Starlink chief arrived with three of his children for the meeting.

According to reports, Prime Minister Modi will be discussing Starlink's entry into

India during his talks with Musk, who plays a very important role in the Donald Trump administration.

Increased sourcing of EV components and Tesla's potential manufacturing in India may also be on the agenda of the talks, the reports said.

The meeting with Musk comes as PM Modi's meeting with US NSA Mike Waltz ended, which was

the first meeting of the day for the PM.

Musk is known to bring along his children for his meetings with top officials, like with US President Donald Trump a day ago, and earlier with Israeli PM Benjamin Netanyahu.
