SUB: INTIMATION UNDER REGULATION 30 OF SEBI (LISTING OBLIGATIONS AND DISCLOSURE REQUIREMENTS), REGULATIONS, 2015, AS AMENDED – REG.

We would like to inform that we had received a notice dated 20.04.2024 from the Legal Metrology Officer, Mathura, Village-Datiya Post-Khamini, Goverdhan Road, Mathura – 281 501 for violation of font size in the packaging stickers mentioning the price of the Quick Dry product, the font size was not as prescribed under Legal Metrology (Packaged Commodities) Rules, 2011. As per the notice, an amount of ₹ 2,25,000/ (Rupees: Two Lakh Twenty Five Thousand Only) was imposed as compounding fee. However, 21.04.2024 (Sunday) being Holiday, the Company paid the compounding fee on 22.04.2024. The intimation is being submitted today after the payment of compounding fees and settlement of the matter.
