**Indian Army Chief General MM Naravane meets Nepal COAS; gifts equipment for field hospitals, ventilators**

**New Delhi** Chief of Army Staff, Indian Army, General MM Naravane arrived in Kathmandu yesterday for a three-day official visit to Nepal, on the invitation of General Purna Chandra Thapa, Chief of Army Staff, Nepali Army. General MM Naravane was received at the airport by Lieutenant General Prabhuram Sharma, CGS Nepali Army and officials of the Indian Embassy.

In a solemn ceremony this morning, General MM Naravane laid a wreath and paid homage at Bir Smarak (Martyr's Memorial) at Army Pavilion in Tundikhel, Kathmandu. He thereafter visited the Nepali Army Headquarters where he was accorded a ceremonial Guard of Honour. This was followed by a meeting with his counterpart General Purna Chandra Thapa, during which both delegations discussed Army-to-Army relations and enhancing bilateral defence cooperation. He was also given a comprehensive briefing by senior officers of the Nepali Army.

On behalf of the Government of India, General MM Naravane presented medical equipment for two field hospitals of the Nepali Army. The equipment include X-Ray machines, computed radiography systems, ICU ventilators, video endoscopy units, anesthesia machines, laboratory equipment and ambulances. Additional ventilators were also gifted to assist Nepali Army in its fight against the Covid-19 pandemic. This follows an earlier army-to-army provision of ventilators in July this year.

**Ashok Gehlot, Sachin Pilot condole death of senior Congress leader due to coronavirus**

**Jaipur** Rajasthan Chief Minister Ashok Gehlot and former Deputy Chief Minister Sachin Pilot have condoled the death of senior Congress leader and former minister, Lalit Bhati, who passed away due to coronavirus related complications.

Lalit Bhati had tested positive for coronavirus a few days ago and passed away on Wednesday night at Jawaharlal Nehru Hospital of Ajmer. He was admitted to the hospital on Tuesday after facing breathing issues.

"News of untimely demise of senior Congress leader, former minister and MLA from Ajmer Mr. Lalit Bhati is saddening. In this difficult time my deep condolences are with the bereaved family members. Pray to God that they give them the strength to bear this loss and give peace to the departed soul. #Rajasthan", Ashok Gehlot, Rajasthan Chief Minister, mentioned.

Known to have a stronghold in Ajmer politics in Rajasthan, Bhati was considered close to Rajasthan Chief Minister Ashok Gehlot.

61-year-old Lalit Bhati first became Congress MLA in 1985. He was the youngest minister in Rajasthan and in 1998, he became MLA from Ajmer East. Bhati had been known for his straightforwardness, had considerable political clout and held various positions in the Congress party. "Saddened to learn of the demise of Sh. Lalit Bhati, former state minister and mla from Ajmer city. He succumbed to Covid related complications last night. I had worked closely with him for many years. My deepest condolences to his family . Om Shanti", Sachin Pilot, Former Deputy Chief Minister, Rajasthan, mentioned in a tweet.

**Bengal Assembly poll: Left-Congress alliance a political jumble?**

**The new CPM-Congress pact in Bengal is set to change things in Bengal ahead of the upcoming assembly election. From voter-base to the exchange and sharing of seats, the tie-up will likely affect both the BJP and TMC.**

The BJP has emerged as the primary opposition party in West Bengal, but its bigger challenge is to be able to retain the position till 2021. With CPI(M) announcing that the party will join hands with Congress in Bengal, a lot is set to change. From voter-base to the exchange and sharing of seats, this pact is expected to impact the BJP as well as the TMC in the state. "The central committee discussed the electoral tactics that the party will adopt in the forthcoming assembly election in the states - Kerala, Tamil Nadu, West Bengal, and Assam. As long as Kerala will concern CPI(M) will

contest along with LDF in this coming assembly election. In Tamil Nadu, CPI (M) will be a part of the DMK-led alliance," Sitaram Yechury, CPI(M) General Secretary announced.

Sitaram Yechury added, "In Assam, the CPI (M) will contest the election in cooperation with all secular parties including Congress to defeat the BJP in the state. This is essential because to stop the dieselisation of social harmony and heaping of the miring of people, especially in the northeastern state. In West Bengal, CPI (M) and the Left Front will have an electoral understanding with all secular parties including Congress to seek the defeat of the BJP and TMC."

The Congress might have welcomed the move but is cautious of ensuring to retain their bastions like Malda and Murshidabad.

Congress MP Pradip Bhattacharya said, "The CPI (M), Left Front, and the central committee have decided to fight together along with Congress. The decision has been to stand against the BJP. The alignment of the Left with Congress will deliver a positive result and it the demand of the people of the country. We will land in the solution for Bengal as well to fight together. Seat sharing will take some time. We stand together in Assam, Uttar Pradesh, etc. I hope that in Bengal, we win the election with this alliance." Bikas Ranjan Bhattacharya, Senior CPI(M) leader reiterated, "This is nothing new as we saw that all the secular parties fought together in the Parliamentary elections as well. In Bengal, we have to fight



BJP and Mamata, so we have decided to fight together. In Bihar also, all parties join hands to stand against BJP and JDU. This is the need of the moment to join hands and save the nation."

Hitting out the alliance, Shishir Bajoria, senior BJP leader said, "It was very clear from the last Lok Sabha election results that we not only won 18 seats from the total 42 but led by 122 seats out of 294 legislative assemblies of West Bengal. We are not far from the margin which is 148. Now, out of 122, we have led with more than 50 per cent of votes in the legislative assembly. In those areas, no matter how many parties merge, it is us who will undoubtedly win. Of this, we have received a majority in north Bengal because we won eight Lok Sabha seats out of the total nine. So it is natural that TMC feels not too well in these areas and can do anything there but these areas are beyond their reach. They can use any strategy, plan or can place any leader but nothing will change. What is

going to happen now is we aim to win 200 seats now."

But the battle is not only about the percentage or number of votes, but there is also a loss of faith. "In 2021, there will be a problem for Congress and CPM as their survival is questionable. Now CPM has 26 seats and they have become so weak that if they do not have the support of Congress, they will not be able to handle the aggression of TMC and BJP. If both Congress and CPM walk together,

then there is a possibility for them because having less than 26 seats may be difficult for the party to stay. Both TMC and BJP are aggressive and Congress and the left can't fight them alone," says political analyst Shikha Mukherjee.

Mukherjee adds, "Therefore their alliance is a political necessity. The Congress and the left are fighting for survival in the 2021 elections. The CPM is down to 26 seats in an assembly of 294 seats. Therefore if it has to survive in West Bengal, it needs the support of the Congress. The aggression from both TMC as well as BJP who are already competing against each other will be difficult for both Congress and the Left to take on these parties where one is a large party and the other is a well-organised and a big party at the national level. Therefore, the need for joint forces and combined resources and fight for survival is critical for both the parties."

**Vikas Dubey case: SIT report points to police-gangster nexus, names over 50 cops**

**A report filed by the SIT in the Vikas Dubey case has revealed a nexus between the police and the slain gangster; 50 policemen have been accused in the report.**

**New Delhi** Over 50 policemen have been named in the police-gangster nexus as pointed in the report filed by the Special Investigation Team (SIT) in the case of slain Vikas Dubey.

In a 3,200 page report, almost 700 pages revealed a nexus between the police and Vikas Dubey.

A total of 80 people have been accused, out of which 50 are police personnel.

According to the latest information, the government is likely to dismiss those accused in the report filed by the SIT. The report revealed



how some policemen kept Vikas Dubey informed about proceedings against him in police stations. It also said that on the day of the incident (July 3), Dubey was informed in advance about the raid and had directed his people to make sure no police personnel could live the spot alive. Eight policemen, including DSP Devendra Mishra, were ambushed in Bikru village in Chaubeypur area of Kanpur when they were going to arrest Dubey and fell to bullets fired from rooftops shortly after midnight on July 3. The SIT had involved around 100 people in its investigation. Which included policemen,

people of Bikru village, many outside police officers and businessmen of Kanpur.

Barring a few, everyone was found to be a part of the nexus with Vikas Dubey for many years.

The SIT had initiated an investigation on 9 points in this case. The time for investigation was given till 31 July but later the time was extended as the scope of investigation increased.

The SIT had also taken officers of various departments including police, revenue, excise and investigation. Vikas Dubey has been killed in an encounter in Kanpur, Uttar Pradesh. The encounter broke out after a police vehicle carrying Vikas Dubey from Ujjain to Kanpur overturned and the gangster attempted to escape. Vikas Dubey snatched a police weapon and opened fire at the police but was surrounded, police said. Vikas Dubey suffered a few bullets shots in the retaliatory fire. He was taken to a Kanpur hospital where doctors declared him dead, police said, adding the history-sheeter was asked to surrender.

**Andhra Pradesh Police rescue another 16,000 street children, test them for Covid-19**

**Hyderabad** Andhra Pradesh Police has rescued 16,457 street children, including child labourers, under Operation Muskaan. The rescued children are now being tested for Covid-19. DGP Gautam Sawang had ordered officials to find out missing children across Andhra and the police formed 794 teams under "Operation Muskaan" to conduct rescue operations in coordination with Child-Line, Child Welfare Committee (CWC), and District Child Protection departments at all railway stations, bus stations, parks, hotels and rescued orphans and children who fled their homes. During the operation, 13,588 boys and 2,869 girls were rescued by authorities. "While a few children were reunited with their families, others were sent to child care centres for further course of action," said the police. The operation was aimed at not only rescuing the children, but also to test them for Covid-19, thereby saving lives. A total of 2,195 kids have already been tested for Covid-19 until now and tests for the rest are still underway. "Unfortunately, out of those whose results have been declared, 631 children have tested positive and are being given necessary medical attention," said an officer part of the operation. AP Police has already conducted three phases of the drive this year starting from January and rescued a total of 25,298 children till date.



**COVID-19 situation deteriorating in Delhi due to rising air pollution, warns CM Arvind Kejriwal Mamata**

**NEW DELHI:** Delhi Chief Minister Arvind Kejriwal on Thursday warned that the COVID-19 situation is deteriorating in the national capital due to rising air pollution. The Chief Minister also made an appeal to the people to avoid bursting firecrackers this Diwali in view of rising air pollution.

Kejriwal added that he along with his cabinet ministers will offer 'Lakshmi Puja' on Diwali and urged people to join them from their homes. The appeal from the chief minister came as Delhi recorded over 6,800 fresh COVID-19 cases for the first time on Wednesday taking the infection tally in the national capital to over 4.09 lakh. 51 new fatalities have pushed the death toll to 6,703, the authorities said on Wednesday night.

The 6,842 fresh cases were diagnosed following the 58,910 tests conducted the previous day, while the positivity rate stood at 11.61 per cent amid the festive season and rising pollution in the city, according to the latest bulletin issued by the Delhi health department. This is the second consecutive day when the number of daily cases has crossed the 6000-mark. The previous



highest single-day spike till date here -- 6,725 cases -- was recorded on Tuesday.

On Wednesday, 51 new fatalities were recorded, pushing the death toll in the national capital to 6,703. Delhi had recorded over 5,000 daily cases for five days on the trot, ending Sunday when the count stood at 5,664. On November 1 too, 51 deaths were recorded. The city had recorded 4,001 COVID-19 cases on Monday. The active cases tally on Wednesday rose to 37,379

from 36,375 the previous day. The bulletin said the total number of cases has climbed to 4,09,938 and the positivity rate stood at 11.61 per cent. The recovery rate on Wednesday was over 89 per cent, the bulletin said. Meanwhile, Delhi Health Minister Satyendar Jain on Wednesday said the government has started conducting targeted COVID-19 tests in markets and other crowded areas to strengthen its surveillance mechanism amid a massive surge in daily cases in the last few days. Official sources said the targeted COVID-19 tests counts are included in the overall tests count. Besides, Delhi health secretary took a review meeting with medical directors and medical superintendents to "discuss the capacity escalation plan". Delhi government has been working on strategies to augment the capacity of beds at COVID-19 hospitals. The number of Rapid Antigen Tests conducted on Tuesday stood at 44,336 while the RT-PCR, CBNAAT and True NAAT tests figures were 14,574 in all adding to 58,910, according to the bulletin. The number of containment zones in Delhi increased to

3,596 from 3,453 on Tuesday. The sudden spike in cases comes amid the festive season and the rising pollution level. While Durga Puja celebrations ended on October 25, the next festivals -- Diwali and Chhath -- are in November. The National Centre for Disease Control in a report drafted recently had warned that Delhi needs to be prepared for about 15,000 fresh cases of COVID-19 per day, taking into account the upcoming winter season-related respiratory problems, large influx of patients from outside and festive gatherings. According to the Wednesday bulletin, out of the total number of 15,782 beds in COVID hospitals, 8,837 are vacant. It said 570 beds in COVID care centres are occupied by persons under quarantine, including travellers who have returned by Vande Bharat Mission and bubble flights. The Delhi government has significantly ramped up testing in the past few days, with the count several times crossing the 60,000-mark. The number of tests done per million, as on Tuesday, was over 2.56 lakh while the total number of tests stood at over 48.8 lakh.

**Fact Check: Tejashwi Yadav did not receive any 'Youngest'**

**New Delhi** As elections are underway in Bihar, a picture of RJD leader Tejashwi Yadav wearing a suit and talking to another man is being shared on social media with the claim that he was conferred the 'Youngest Politician' award in London. The claim in Hindi translates to, "Enough with 9th fail taunts. Tejashwi Yadav was conferred the 'Youngest Politician' award in London at an age when your father used to sell tea."

Text in Hindi superimposed on the picture translates to, "Someone was begging at the age of 30 even after producing fake certificates. Someone was making a mark for himself in London at the age of 30 even as a 9th fail." India Today Anti Fake News War Room (AFWW) has found the claim along with the picture to be false. This 2016 image is of Tejashwi interacting with members of the Institution of Civil Engineers (ICE) in London. He has not received any 'Youngest Politician' award in London. The archived versions of similar posts can be seen here and here.

Using reverse image search, we found an uncropped version of the viral image shared by Tejashwi himself in 2016 on his verified Twitter handle. The caption of the image reads, "Attending a knowledge sharing session with ICE members in London". On his official Facebook page, Tejashwi, who was then deputy chief minister of Bihar, had also shared the transcript of his speech at ICE where he spoke about efforts in improving the transportation infrastructure of Bihar. We also found news reports from 2016 on Tejashwi's London visit. According to reports, Tejashwi was on a trip to England from August 8-15, 2016.
