**Premier Synthetics Limited**

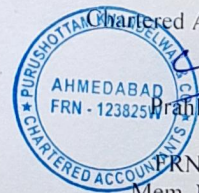

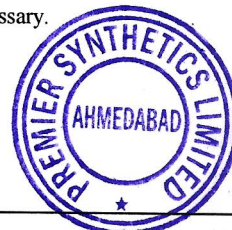
