Sub: Update on Law suit filed against former employees and its related entity QualiZeal Inc  
Ref: Company's letter dated 1<sup>st</sup> December 2021 regarding outcome of Board meeting under regulation  
30 of SEBI(LODR) Regulations, 2015

Further to our letter dated 1<sup>st</sup> December 2021, we inform the Exchange that the company Cigniti Technologies in Dec 2021 has filed with exchanges as regards proceeding against its ex-employees in USA who have committed fraud and breach of fiduciary duties. In this regard we further state that we have pursued the legal suit and have received an interim injunction as mentioned below:

“In continuation to the law suit filed by Cigniti Technologies Inc USA (subsidiary of Cigniti Technologies Ltd.) in 2021 against its former employees Pradeep Govindasamy, Kalyana Rao Konda and Hyderabad based company QualiZeal, Dallas County District Court has passed an interim injunction in favor of Cigniti Technologies.

The court has found the supporting evidence that Pradeep, Kalyan, Ravi Sindri, Ashwin Bakshi, Koteswara Rao Bipilli, Ramanathan Ponnusamy, and Doug Hall, other individuals who left Cigniti and joined QualiZeal have indulged in breach of contract, breach of fiduciary duty, tortious interference with prospective and existing contracts of Cigniti, for fraud, conspiracy, aiding and abetting.

The court in its interim injunction ordered the above mentioned individuals and others in concert from directly or indirectly soliciting or accepting business from any person or entity that was client of Cigniti's for the period October 1, 2020 through November 30, 2021; and (ii) any person or entity that was prospective client of Cigniti, as known by Cigniti and any of the Individual Defendants, for the period October 1, 2020 through November 30, 2021 and also return any and all confidential data, confidential, proprietary information and trade secret they possess which belongs to Cigniti Technologies.
