Nagpur BJP Leader Missing in Jabalpur: Suspect asked dhaba worker to wash his car with blood stains

Nagpur8August: In a significant development regarding the missing Bharatiya Janata Party (BJP) West Nagpur leader Sana Khan in Jabalpur, sources have revealed a major breakthrough to reporters. Police have interrogated a Dhaba worker of Amit Sahu, the prime suspect in the case, who told authorities that Sahu had asked him to wash his car before leaving form Jabalpur. During the cleaning, the worker reportedly discovered blood stains in the car along with some clothes. He also informed the police that Sahu had obtained a SIM Card using his Aadhar Card before fleeing Jabalpur. According to police sources, cops are now convinced that the accused Sahu has killed Khan and disposed of her body, although locating the body will be a challenging task.
