India has been 'prisoner of its past image': Jaishankar

India has been "prisoner of its past image" and the country must get over it, External Affairs Minister S Jaishankar said on Wednesday, noting that an effort to "rebalance" its approach in dealing with key challenges was underway. Answering a question at the Raisina Dialogue on how his ministry is dealing with criticism over Kashmir, NRC and the new citizenship law, he said the key question should be whether India is going to define itself or will it allow others to define it. "One aspect of re-balancing where India is concerned is today are we going to define ourselves or are we going to let other people define us. I would like to believe that it is the first. That is my political outlook and that of my party," he said. He said it is important to reflect on how India responded to common chal-



lenges which were faced by many countries globally. "Even something like naturalisation, what is the pathway the other nations have taken with regard to naturalisation of people. I think it is worthwhile looking at it," Jaishankar said. "Don't get fixated on the dots and ignore the line. These are important issues. At the end of the day they reflect the mindset towards governance," he said. "A lot of what has happened in the last six months are sort of in the

political sphere but the same mindset was also evident when it came to socio-economic issues," he added. India has faced criticism from many countries over the lockdown in Kashmir, the roll out of National Register of Citizens in Assam as well as on the new citizenship law. Asked on India's poor track record of implementation of development projects abroad as well as challenges in foreign policy domain, he said the country is a "prisoner of its past image" and it must get over it. Jaishankar indicated that the current government inherited a lot of problems and the effort now has been to not pass on them to future governments. "The bottomline is: are we going to just inherit problems, multiply them, pass it on, or are we going to deal with some of them and probably leave the people who come after us better off," he said.

350-ft Ambedkar statue to be ready in 2 yrs: Ajit

The Maharashtra Government has decided to increase the height of the proposed statue of Bharat Ratna Dr BR Ambedkar from the originally planned 250 feet to 350 feet, standing on a 100 feet high pedestal, Deputy Chief Minister Ajit Pawar said here on Wednesday. "The Cabinet viewed a presentation of the grand memorial project and approved the proposal to augment the height of the bronze statue by 100 feet. The project is expected to be completed within two years and there would be no dearth of funds for it," Pawar told mediapersons. Prime Minister Narendra Modi had laid the foundation stone for the 'State of Equality' in Oct. 2015, in the Indu Mills Compound, spread over 12.50 acres land. The proposed grand memorial to Ambedkar - the Architect of Indian Constitution - will have a 600-seat auditorium, a 400-capacity library and research centre, symbols and artefacts of Bud-

dism, a six-metre wide circular pathway around the memorial. "The project will be supervised by the Mumbai Metropolitan Region Development Authority (MMRDA), and will be an eco-friendly monument with 68 percent free spaces without disturbing the local environment on the Arabian Sea shores. He alleged that the previous Bharatiya Janata Party-led government did nothing in the matter during its tenure, but now the matter has been speeded up to complete it within two years. However, Republican Sena President Anandraj Y Ambedkar, the youngest grandson of Dr B. R. Ambedkar, accused Ajit Pawar of "misleading" the people as the original height of the statue was 350 feet. "We have demanded that the statue alone should be 450 feet tall, besides the pedestal height. After

we raised this demand, the height of Statue of Unity of Sardar Vallabhbhai Patel was increased to almost 600 feet," Anandraj Ambedkar said.

Indo-Pacific concept initiated to disrupt existing structure, contain China

NEW DELHI: Hitting out at the US over the concept of the Indo-Pacific, Russian Foreign Minister Sergey Lavrov on Wednesday said it was initiated to disrupt the existing structure and contain China. Addressing the gathering at the Raisina Dialogue, he also said that an equitable democratic order should not be influenced by use of brutal force. Lavrov also backed India and Brazil to be permanent members of the UN Security Council. The new Indo-Pacific concept being pushed by the US, Japan and others is an attempt to reconfigure the existing structure, he said.

"Why do you need to call Asian Pacific as Indo-Pacific? The answer is evident - to exclude China. Terminology should be unifying, not divisive. Neither SCO nor BRICS is exclusionary," Lavrov said. "When we asked the initiators how Indo-Pacific is different from Asia Pacific, we were told it is more democratic. We don't think so. It is rather tricky. We have to be careful about the terminology which looks benign but is not," he said. The Indo-Pacific has been a major focus area of India's foreign policy in the last few years and the country pushing for the peace and stability of the region.

AAP dares Gambhir to give up free facilities, MP hits back

Delhi's ruling Aam Aadmi Party (AAP) on Wednesday dared BJP's Lok Sabha MP Gautam Gambhir to first give up all the free facilities he enjoys as an MP, after he opposed free facilities for the public, which claim has been denied by the cricketer-turned-politician. Speaking to the media, AAP Rajya Sabha MP Sanjay Singh said the BJP and its leaders can say whatever they want

but the AAP government, if elected again, will continue free services for the next five years. "BJP leaders continuously oppose free facilities provided to the people of Delhi, now Gambhir has joined the list." Singh said that Gambhir should first give up all the free facilities he enjoys as an MP before opposing free facilities for the public. He said the BJP leaders are continuously opposing the free welfare schemes of the AAP government.

Singh reassured the people of Delhi that the BJP's statements do not matter, because after coming to power, the AAP government will continue all the current welfare schemes. "Several leaders of the BJP have time and again conveyed their anti-development and regressive stance including opposition to basic services such as electricity and water being free, and it is good that their true intentions have been revealed before the assembly elections are held."

Modi should clarify...
"Absolutely wrong allegation. Congress never officially supported Dr Zakir Naik. It is true I had addressed a Communal Harmony conference in Mumbai from his platform but you can go through his speech in that conference, at no point he made any communally sensitive statement." In his another tweet, he mentioned that when people disagree with them, they "1. Try to make them agree; 2. If not, threaten them; 3. If they still do not agree, try to lure them with post and money; 4. If they still do not agree, malign them with false allegations; 5. If they agree, all allegations are retracted and if not, then declare them traitors and publicise this widely; 6. If there is such occasion when they (dissenters) could be used, they do what Zakir Naik has mentioned".

Setting up police...
Nevertheless, he could not do that because of pressure from the IAS lobby. Similarly, Nath was going to declare on August 15 that, the system would be in place in the state, but the IAS Association stopped it. There were speculations that the Chief Minister would announce setting up police commissioner system from Indore on the Republic Day this year. Nevertheless, the Chief Minister's statement on Wednesday indicated that the plan to set up police commissioner system was swept under the carpet. The police commissioner system has already brought IAS and IPS officers face to face several times.

Teacher given forced...
The department had given forced retirement to 16 teachers as their school fared poorly in board exams. However, as teacher association protested against the move, the department asked the concerned teachers to come up with an explanation. If their replies were found satisfactory their forced retirement will be cancelled, the teachers were told.

Gutka barons donated...
The documents seized from the factories during the raids reveal huge donation made to a political party over years. Owners of the factory Kamal Kant Chourasia, a resident of Kanpur, franchise holder Sheikh Mohammad Arif and Vaibhav Pandey residents of Bhopal kept the political party in good humour giving huge donations. If at all they faced any administrative issues, the politicians using their clout managed the officials and settled things. Enjoying political patronage, the gutka industrialists ran their business keeping all norms at bay and allegedly evading tax to the tunes of crores of rupees. For years, the officials of GST (tax department) did not visit the factory and if at all they came to the factory they remained confined to the office cursory checking the documents. It is claimed that electricity department did not conduct any audit in last seven years. It was ten years back that food and drug department had collected the sample; no one took pain to visit the factories in last many years. The officials of weight and measurement department too paid a visit to the factories five year ago.

Real estate player...
Sources said that few other associates of Agrawal were also under the action. These include Arun Goyal, Shyam Goyal, Dr. Gokuldas and Kalyan Tolls. The associates are facing the survey action. In the city, Manishpuri, Baikuntha Dhaam Colony, New Palasia, Rani Sati Gate, Race Course Road and Siyaganj are prominent locations where search and survey actions were launched simultaneously in the morning. Income Tax sleuths were tipped off about large amount of black money is being used in the real estate projects of Vijay Agrawal and its associates, who are relatives too. Agrawal family initially ventured into the business of selling commonly used grocery and religious commodities in Siyaganj from a shop named as Anant Upyogi Vastu Bhandar. Later Vijay diversified the family business into real estate sector and formed a real estate company Lord Anand Developer's Private Limited under the brand name Empire Group. The group is mainly executing projects of Bypass and Ring Road in the city.
