CLOSURE DIRECTION UNDER SECTION 33 (A) OF THE WATER (PREVENTION AND CONTROL OF POLLUTION) ACT-1974 (HERE IN AFTER REFERRED TO AS THE 'WATER ACT') AS AMENDED FROM TIME TO TIME.

WHEREAS you are having an industrial plant at Survey No. 69/1/p3,69/1/p/3/p1,72/p3, 73/p1,74/p3,76/2p1/,75/1p4,83,84,86/6/p1,89/9/p1,p2,93/p2,94/p1 and p2, Ta: Umbergaon, Dist: Valsad- 396 155.

ANDWHEREAS, the Board has granted Consolidated Consents & Authorization, order No. AWH - 103572 dated 17/08/2019, which is valid up to 11/04/2025 for operation of industrial plant for the manufacturing of Writing Printing & News Print Paper & Captive Power Plant.

ANDWHEREAS, Closure direction was issued under Section-33(A) Of the Water (Prevention and Control of Pollution) Act, 1974 as amended from time to time vide letter no. GPCB/CCA-SRG-512(9)/ID-26286/685166, dated 04/10/2022.

ANDWHEREAS, you have applied for revocation with relevant documents, undertaking and submitted bank guarantee of Rs. 7.5 lakhs. Unit has paid Interim Environmental Compensation of Rs. 12.60 lakhs on 20/10/2022. Subsequently trial revocation was issued on 20/10/2022 for three months with the conditions mentions therein.

ANDWHEREAS, your industrial plant was inspected under section- 23 of The Water Act, 1974 on 21/06/2023 by the authorized officers of the Board & following were observed:-

- 1. SOG official has given letter and requested to draw sample from tractor tanker having RTO registration no GJ-15-CK-3803, which was in custody of SOG, Valsad at Sarigam from farm of Mr. Piyushbhai Joshi village Angam. Tractor tanker had lifted wastewater from septic tank located within premises of M/s N R agrawal industries (Unit-V).
- 2. Analysis report of sample collated from tractor tanker No. GJ-15-CK-3803 shows; COD 4894 mg/l & BOD 1380 mg/l, which is higher than Norms.
- 3. Unit has not complied CCA conditions under water act.

ORDER

UNDER THE CIRCUMSTANCES, I.R. B. Trivedi, Environment Engineer Gujarat Pollution Control Board is directed to issue the Directions under Section 33 (A) of the Water (Prevention and Control of Pollution) Act-1974 as under:-

- 1. That you shall stop operation of your industrial plant including DG Set and Captive Power plant with 15 days effect.
- 2. That the concerned authorities shall stop supply of Electricity and other services to your plant with 15 days effect from the date of issue of this order.
- 3. Industry shall submit Bank Guarantee of Rs. 15 Lakh of scheduled Bank, which is payable in state of Gujarat.
- 4. Industry shall be liable to pay Environmental Damage Compensation as decided by the anduss. Board.

If the above directions are not complied, you are liable for prosecution under section 41(2) of the Water (Prevention and Control of Pollution) Act-1974 which provides punishment with imprisonment for a term not less than one year and six months and May extended to six years with fine.

If any person aggrieved by aforesaid direction, you may file an appeal under Section 33B of the Water (Prevention and Control of Pollution) Act. 1974 before National Green Tribunal within thirty days from the date of this order.
