- Any person, who becomes Member of the Company after despatch of the Notice of AGM and holding shares as of the said cut-off date, may obtain the login ID and password by sending a request at evoting@nsdl.co.in. However, if a Member has already registered with NSDL for remote e-voting then the Member can use their existing user ID and password for casting their vote.
- The Members who have not cast their vote through remote e-voting, can exercise their voting rights during the AGM. The procedure for e-voting at the AGM is same as the procedure for remote e-voting. Members who have cast their vote through remote e-voting may also attend the AGM but shall not be entitled to cast their vote again.
