SC relief to PC in ED case till Sept 5

It is rare that an anticipatory bail plea is heard so extensively and the time taken by a bench of Justices R Banumathi and A S Bopanna indicates the stakes involved for ED and Chidambaram in the context of allegations of a political witch-hunt.

The bench heard arguments of senior advocates Kapil Sibal and A M Singhvi for Chidambaram and solicitor general Tushar Mehta at length. Mehta vehemently opposed Chidambaram being protected from the ED, and said the leader's contention that he could not be arrested without the agency first presenting to him evidence in the case was absurd and preposterous. The SG said this would adversely affect probes into money laundering cases against fugitives like Vijay Mallya, Nirav Modi and Mehul Choksi and terror funding cases involving Hafiz Saeed in which money laundering of more than Rs 50,000 crore was involved.

Chidambaram's CBI custody ends on Friday, and it remains to be seen if the agency

Chidambaram's CBI custody ends on Friday, and it remains to be seen if the agency seeks an extension and what the court's response will be

seeks an extension and what the trial court's response will be. As police custody is of 14 days and Friday is the eighth day, the CBI can seek another six days. However, if the court does not agree, Chidambaram could be released on Friday. The SC bench directed the ED to file documents pertaining to the case in a sealed envelope and said it would decide whether to go through it or not. It also posted Chidambaram's plea against the trial court order remanding him to CBI custody on Monday.

Chidambaram had approached the apex court on the same day (August 20) the Delhi high court dismissed his anticipatory bail plea and his petition was listed for hearing on August 23. He was arrested by CBI on August 22 and this led to the apex court dismissing his petition.

Ex-coal secy cleared in one Coalgate case

New Delhi: A court here on Thursday acquitted former coal secretary **HC Gupta** and Delhi-based Pushp Steels and Mining Pvt Ltd in a corruption case related to allocation of a Chhattisgarh-based coal block, after the CBI "miserably failed" to prove charges of criminal conspiracy, criminal misconduct, and criminal breach of trust by a public servant. Gupta was the coal secretary from December 2005 to November 2008. Pushp Steels was allotted Brahmapuri coal block in Chhattisgarh on the recommendation of the screening committee for its proposed sponge iron end use project in Durg district. The order, by



Special Judge Bharat Parashar, stated, "None of the circumstances/allegations levelled against the two accused stands proved much less cogently proved so the question of the proved facts and circumstances forming a chain of circumstance so complete as not to leave any reasonable ground for any conclusion consistent with the innocence of accused or otherwise does not arise at all."

"...the prosecution has been held to have failed in proving any of the charges ie either for the offence of criminal conspiracy ie under section 120-B IPC or for the offence of criminal misconduct," said the order. PTI
