Sonowal holds discussion with
Jorhat Chambers of Commerce

DISPUR, SEPT 8 /- Chief Minister Sarbananda Sonowal today held a meeting with the members of Chambers of Commerce of Jorhat district at the conference hall of Jorhat Circuit House and discussed with them several problems they faced in the post lockdown period of the COVID-19 pandemic. UP lifts weekend curbs on markets

LUCKNOW, SEPT 8 /- The Uttar Pradesh government today revoked its order of mandatory closure of markets on Sunday, reverting to the pre-coronavirus lockdown arrangement. Ac-

ording to a statement, Chief Minister Yogi Adityanath said in a review meeting that markets will now close as per their earlier schedule instead of the weekly closure on Sunday. He said except containment zones, hotels and restaurants should be made operational in all areas and it should be ensured that all safety measures are followed. The chief minister asked officials to take measures for the protection of health workers from the infection. At the meeting, the CM also directed to speed up development work at seven cities under the Smart City Project and asked officials for a regular monitoring. (PTI)
