Subject: Consolidated Scrutinizer's Report on remote e-voting process and poll conducted at 27th Annual General Meeting (AGM) of Sarthak Metals Limited (the Company) held on Monday, 5th September, 2022.

The Board of the Company at its meeting held on 6th July, 2022, appointed me as a scrutinizer for the remote e-voting held between 2nd September, 2022 to 4th September, 2022 and the Chairman of 27th Annual General Meeting (AGM) has appointed me as the scrutinizer for the poll held at AGM of the Company on Monday, 5th September, 2022.

The Chairman of the AGM had appointed me as the scrutinizer for the same.

I hereby submit my following consolidated report on remote e-voting together with the poll.





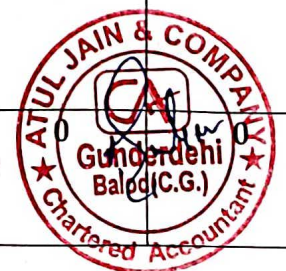

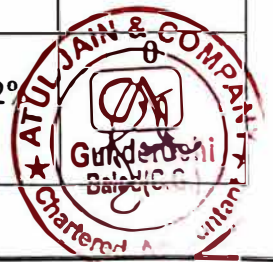
