रेलवे ने 477 समपार वाले 250 स्टेशनों की पहचान की

जसरात ब्यूरो नई दिल्ली, 15 मई।

देश भर में ऐसे 477 मानवयुक्त समपार हैं, जो ट्रेनों के सुचारु संचालन में बाधा पैदा कर रहे हैं। रेलवे सूचना प्रणाली केंद्र

(सीआरआइएस) ने रेलवे उपग्रह आधारित ट्रेन लोकेशन ट्रैकिंग डेटा का उपयोग कर ऐसे 250 स्टेशनों की पहचान की है। रेलवे के अनुसार देश के रेलवे नेटवर्क में करीब 477 मानवयुक्त समपार फाटक, जहाँ औसतन प्रतिदिन एक घंटे से अधिक की देरी से ट्रेनों का संचालन होता है।

लाटरी कारोबारी की 457 कराड़ की संपत्ति जब्त

नई दिल्ली, 15 मई (भाषा)।

'लाटरी किंग' सैंटियागो मार्टिन के खिलाफ दर्ज मामले की जांच के दौरान धनशोधन बोधी कानून के तहत लगभग 457 करोड़ रुपए की संपत्ति जब्त की गई है। प्रवर्तन निदेशालय (ईडी) ने सोमवार को यह जानकारी दी। यह मामला केरल में लाटरी की बिक्री में हुई धोखाधड़ी से कथित तौर पर सिक्किम सरकार को हुए 900 करोड़ रुपए के नुकसान से संबंधित है। एजेंसी ने 11 और 12 मई को कोयंबटूर और चेन्नई में मार्टिन तथा उसके परिवार के सदस्यों के खिलाफ और कोयंबटूर में फ्यूचर गेमिंग साल्यूशंस इंडिया प्राइवेट लिमिटेड नामक कंपनी के आधिकारिक परिसरों पर नए सिर से छापेमारी की।

केरल में लाटरी बिक्री में हुई धोखाधड़ी से सिक्किम सरकार को हुए 900 करोड़ रुपए से जुड़ा मामला

'फ्यूचर गेमिंग साल्यूशंस इंडिया प्राइवेट लिमिटेड' सिक्किम लाटरी का मुख्य वितरक है और प्रवर्तन निदेशालय (ईडी) मार्टिन से पूछताछ कर रहा है, जिसे 2019 से तमिलनाडु में 'लाटरी किंग' के रूप में जाना जाता है। धनशोधन का मामला केरल में सिक्किम सरकार की लाटरी की बिक्री से संबंधित कथित अपराधों के लिए मार्टिन और अन्य के खिलाफ दायर सीबीआइ आरोप पत्र से संबंधित है। ईडी ने एक बयान में आरोप लगाया है, मार्टिन और उनकी सहयोगी कंपनियों व संस्थाओं ने 01.04.2009 से 31.08.2010 की अवधि के दौरान पुरस्कार विजेता टिकटों के दावों को बढ़ा-चढ़ा कर दिखाकर अवैध लाभ कमाया, जिससे सिक्किम सरकार को 910 करोड़ रुपए का नुकसान हुआ।

नवलखा की याचिका का एनआइए ने किया विरोध

नई दिल्ली, 15 मई (भाषा)।

राष्ट्रीय न्यायिक अधिकरण (एनआइए) ने एल्यार परिषद-माओवादी संबंधी मामले के आरोपी गौतम नवलखा को उस अर्जी का सोमवार को विरोध किया, जिसमें उन्होंने खुद को महाराष्ट्र के रायगढ़ में अलीबाग क्षेत्र स्थित एक घर में नजरबंद रखने का अनुरोध किया है। नवलखा फिलहाल मुंबई के एक सार्वजनिक पुस्तकालय में नजरबंद हैं। एनआइए और महाराष्ट्र सरकार की ओर से पूर्व अतिरिक्त सलिसिटर जनरल एसवी राजू ने न्यायमूर्ति केएम जोसेफ और न्यायमूर्ति बीवी नागरत्ना की पीठ को बताया कि नवलखा को उनके अनुरोध पर अलीबाग के घर में रखना संभव नहीं होगा क्योंकि यह निचली अदालत से 110 किलोमीटर दूर है तथा इस दूरी को तय करने में कम से कम साढ़े तीन घंटे लगते हैं। उन्होंने कहा, 'दूसरी समस्या यह है

अलीबाग इलाके में नजरबंद रखने के संबंध में जुड़ा मामला, घर में रखना उन्हें संभव नहीं, निचली अदालत से 110 किलोमीटर दूर, दूरी तय करने में लगते हैं साढ़े तीन घंटे

कि अलीबाग का यह घर रिहायशी इलाके में स्थित है, जहां घेरा डालना बहुत ही कठिन है। इसलिए सुरक्षा की दृष्टि से भी यह संभव नहीं है।' राजू ने यह भी दलील दी कि याचिकाकर्ता ने इससे पहले चिकित्सा के आधार पर जेल की जगह नजरबंद रखने का अनुरोध किया था और उस वक्त कहा था कि उन्हें अच्छी स्वास्थ्य सुविधाएं नहीं मिल रही हैं, लेकिन अब वह जिस इलाके में नजरबंद रखने का अनुरोध कर रहे हैं वहां कोई भी सुपर-स्पेशलिटी अस्पताल उपलब्ध नहीं है। उन्होंने कहा, 'इस प्रकार नजरबंदी के लिए दिया गया उका आंध्र नाटक था।' नवलखा की ओर से पेश चर्खे अधिवक्ता नित्य रामकृष्णन ने एनआइए की दलील का विरोध किया और कहा कि वह नजरबंदी के स्थान के निर्धारण का मामला बातचीत से सुलझाने को तैयार हैं। पीठ ने अतिरिक्त सलिसिटर जनरल राजू से कहा कि वह अपनी आपत्तियां लिखित में दें और मामले की अगली सुनवाई 18 अगस्त तक टाल दी। शीर्ष अदालत ने नवलखा को नजरबंदी की अवधि कई बार बढ़ाई है।
