Dear Sir,

The Board of Directors of the Company at its Meeting held on 02.09.2020 has appointed me as the Scrutinizer for scrutinizing the E-voting process as required under the Companies Act, 2013 in respect of Resolutions included in Notice dated 02<sup>nd</sup> September, 2020.

The Notice dated 02<sup>nd</sup> September, 2020 were sent to the Shareholders in respect of the below mentioned resolutions passed at the Annual General Meeting of the Company.

The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting remote e-voting by the Shareholders of the Company.

The Company has also provided voting facility to the Shareholders present at the Annual General Meeting and who had not cast their vote earlier through remote e-voting facility. The shareholders of the Company holding shares as on the "cut-off" date of September 23, 2020 were entitled to vote on the resolutions as contained in the Notice of Annual General Meeting.

The voting period for remote e-voting commenced on Sunday, 27<sup>th</sup> September, 2020 at 9.00 A.M. and ended on Tuesday, 29<sup>th</sup> September, 2020 at 5.00 P.M. and the NSDL e-voting platform was blocked thereafter.



After the closure of voting at the Annual General Meeting, the report on voting done at the meeting was generated in my presence and the voting was diligently scrutinized.

The votes cast under remote e-voting facility were thereafter unblocked in the presence of two witnesses who were not in the employment of the Company and after the conclusion of the voting at the Annual General Meeting the votes cast there under were counted.

I have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the National Securities Depository Limited (NDSL) e-voting system and the ballot forms received respectively.
