**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Update on operations of Company's Plants.**

Dear Sir,

The country is facing difficult situation due to COVID 19 Pandemic and consequent countrywide lock down announced by the Government of India. This has an adverse impact on the overall Indian Economy and our Company is not an exception. The Government vide order dated 22<sup>nd</sup> March, 2020 exempted few industries to continue with the production during the lock down period. As our Company is manufacturing Agro Chemicals, therefore, was under the exempted category. Accordingly, the operations in the manufacturing units of the Company were not stopped permanently and fully, but continued with the available manpower and other resources.

In the initial period, there was temporary working problems due to less attendance of manpower, which improved later on after permission from the authorities. Therefore required number of workers and employees were attending work as per the requirement. The office work was done by most of the employees from home. That was allowed to avoid gathering of many people in the office and to restrict movement and for their safety. In nutshell, the factory operations were continuing with the minimum possible workers and staff as required for the smooth operations and within the approved workforce allowed by the government authorities.

The employees who were attending the duties were given necessary instructions and advise to strictly practice social distancing, use face mask, gloves, regular washing of hands and to follow all the guidelines issued by the authorities for prevention of COVID 19. Employees were screened for temperature and sanitized at the entrance gate of the factory. Sanitizer is also available at various places inside the factory premises. Therefore, all required precautions were taken for working during the lock down period.
