

## MAD SCRAMBLE TO DEATH...

Taliban officials, however, said they had received no reports of any clashes anywhere in the country. The group controls 90 per cent of the state buildings and fighters were told to prevent damage, an official said. Mohammad Naem, a spokesman for Taliban's political office, said "Thanks to God, the war is over in the country." The US Embassy has been evacuated and the American flag lowered, with diplomats relocating to the airport to aid with the evacuation. Other Western countries have also closed their missions and are flying out staff and nationals. Afghans are also trying to leave through land border crossings, all of which are now controlled by the Taliban. Rakhmatulla Kuyash, 30, was one of the few people with a visa allowing him to cross into Uzbekistan on Sunday. He said his children and relatives had to stay behind. "I'm lost and I don't know what to do. I left everything behind," he said. A senior US official said "it's heart breaking" to see what's happening in Kabul, but that President Joe Biden "stands by" his decision to pull out because he didn't want the war there - already the longest in US history - to enter a third decade. In interviews with US television networks, National Security Adviser Jake Sullivan blamed the Afghan military for the Taliban's rapid takeover, saying it lacked the will to fight.

## BIDEN & JOHNSON: SHAMEFUL...

The Trump administration had negotiated the terms of a U.S. withdrawal in talks with the Taliban last year. However, the Americans did not anticipate the speed of a Taliban advance three weeks ahead of President Biden's August 31 deadline to bring all troops home. Biden has repeatedly said he has no regrets about pushing ahead with his timetable. Likewise, Tory MPs have accused Prime Minister Boris Johnson of a 'shameful' silence, describing Afghanistan's collapse as 'the biggest single policy disaster' and questioned whether he did enough to persuade President Biden to not pull out US troops.

## AT PRESIDENT'S DESK...

Established by George W Bush in 2002, suspected terrorists have been detained without trial and tortured at the facility. Donald Trump signed an executive order to keep the centre open indefinitely in 2018, while in February the Biden administration vowed to shut Guantanamo down. A Taliban spokesman promised there would be 'no revenge' against those who worked with the previous Afghan government but refused to guarantee that Afghans would be allowed to flee.

## MEA MONITORING...

"The security situation in Kabul has deteriorated significantly in the last few days. It is changing rapidly even as we speak," Bagchi said. He said there are a number of Afghans who have been India's partners in the promotion of mutual developmental, educational and people-to-people endeavours and India will stand by them. "We have been issuing periodic advisories for the safety and security of Indian nationals in that country, including calling for their immediate return to India," he said. Commercial flight operations from the Kabul airport have been suspended. "This has forced a pause in our repatriation efforts. We are awaiting the resumption of flights to restart the process," Bagchi told reporters.

## CENTRE YIELDS, PANEL TO LOOK...

"We have denied all allegations...the IT Minister has clarified that a web portal published a sensational story before Parliament session began. There is nothing to hide or that needs examination. It's a scientific thing and we will appoint a neutral body of persons and experts to dispel any wrong narrative spread by certain vested interests and with an object of examining the issues raised. What more can the Centre do? This is transparency," said the Solicitor General. Mehta impressed upon the Court the need to have a committee of experts appointed only by the government to look into issue. To this, CJI Ramana queried, "How will the technical committee check what authorizations have been given? What contracts were signed with respect to the issue of permission, sanction, procurement, non-procurement, etc?" SG Mehta replied that the Court can come up with the terms of reference of the committee of experts. "There is nothing to hide, you can confer the jurisdiction upon the committee," said Mehta.

## 'There should be...

The leader also said that the power of identification of OBCs vested with the states would result in agitation by affected ones. "If some new castes are identified as part of OBCs which, of course, will be eligible for the reservation then the prospects of those already in the beneficiary list will be affected and then there will be a new dispute", he added. On Pegasus issue, Solanki said, "The Centre's announcement to constitute a committee to inquire into Pegasus issue is a welcome step. Had we left the issue on SC, the Parliament would have been saved from the disruptions. The same (step) should be followed in farmers' agitation." However, Solanki who praised Prime Minister Narendra Modi's speech from Lal Quila on Independence Day as a historic one said, "My tweets are to make the parliamentary democracy transparent, people friendly and trustworthy. Drawing inferences from the same as support or opposition to anyone is a matter of concern (for me)."

## EOW rushes messenger...

However, the central agency is still demanding the same, said another EOW officer. The EOW had sent details to CERT-In for certification of the tampering. # Priority should be to evacuate citizens: Ex-Indian diplomats

NEW DELHI

Former Indian diplomats on Monday termed the Taliban's takeover of Afghanistan as a "setback" for India strategically, and asserted the priority for New Delhi right now should be to evacuate its citizens from the war-torn nation. Anil Wadhwa, who served as Secretary (East) in the Ministry of External Affairs before retiring in 2017, said the Taliban seizing control of Kabul was a "setback" for India in strategic terms.

Advocating a "wait and watch" approach for India towards Afghanistan, he told PTI that "from the initial signs it seems the Pakistani ISI is controlling the Taliban right now through the Haqqani faction."

Wadhwa said India's future course of action will depend on how Taliban will behave in the future and whether it will use Afghanistan as a springboard to carry out terrorist attacks.

## EVACUATE INDIANS FROM AF GURDWARAS: CAPT

CHANDIGARH: Punjab CM Amarinder Singh on Monday urged the Centre to arrange evacuation of all Indians, including 200 Sikhs who were stuck in a gurdwara in Afghanistan, and said his government was willing to extend any help needed for the same. In a tweet, Singh said, "Urge @DrJaishankar, MEA, Gol, to arrange for immediate evacuation of all Indians, including around 200 Sikhs, stuck in a Gurdwara in Afghanistan after the #Taliban takeover. My govt is willing to extend any help needed to ensure their safe evacuation".

# Drought-like situation in 6 Rajasthan districts

Weather is once again playing up with the desert state of Rajasthan as six districts are facing drought-like situation. This is monsoon time and there is no rainfall activity in the western areas of the state for over 10 days. The average rainfall is deficient by up to 58 per cent in these districts. What is interesting is that 4 districts received almost double their average rainfall in the same time and witnessed flood-like situations.

Uneven rainfall is a common phenomenon in Rajasthan, as western districts comprising of desert areas receive lesser rain than eastern and

southeastern districts but this time the gap is extreme. Western districts like Jodhpur, Barmer, Bikaner, Jalore and Sirahi and a northern district, Ganganagar, received average rainfall of only 42-55 per cent in this monsoon season till date. Monsoon is active in Rajasthan till September 15-20, so now only around one month is left and if situations remain like this, then this area will face drought considering that there are no rivers and only 5 per cent of water is left in the 123 reservoirs of the area. CM Ashok Gehlot is concerned about the deficient rainfall in the area and ordered a special survey of the crop loss in these districts.

## 'UNCONTROLLED' AFGHAN AIRSPACE

# Air India diverts Chicago-Delhi flight

NEW DELHI: Air India on Monday diverted its Chicago-Delhi flight toward Sharjah in the UAE to avoid Afghanistan airspace after it was declared "uncontrolled" by authorities at Kabul airport, senior officials said. The Chicago-Delhi flight will land in Sharjah for refuelling purposes, they said. The flight will then leave for Delhi again while avoiding the Afghan airspace. Afghanistan states at an uncertain future as President Ashraf Ghani left the country just before Kabul fell into the hands of the Taliban on Sunday. As Afghanistan fell into the hands of Taliban, Indian carrier Vistara has said that it will not operate its Delhi to London flights over the airspace of the country. The decision was taken after Afghanistan airspace was declared "uncontrolled" by the Kabul airport and transit flights have been asked to avoid it.

An official of the Afghan embassy on Monday suggested that its Twitter handle was hacked after several tweets criticising embattled Afghan President Ashraf Ghani for fleeing the country were posted from it. Abdulhag Azad, the press secretary of the Afghan embassy in India, tweeted that he has lost control of the mission's official Twitter handle, along with a screen shot of one of the messages slamming Ghani for leaving Afghanistan.

## Mother of Keralite woman in Kabul jail cries for help

Thiruvananthapuram: The mother of Nimisha Fathima, a Keralite woman who landed in a jail in Afghanistan following the killing of her IS fighter husband in an attack there a couple of years ago, on Monday said she was concerned about her daughter's safety after the Taliban captured power in that country and hoped that the Central government will make efforts to bring her back to India.

NOTES : (1) The National Company Law Tribunal (NCLT) Indore Bench at Ahmedabad vide order dated 17<sup>th</sup> September 2020 (Insolvency Commencement Date) has initiated Corporate Insolvency Resolution Process (CIRP) u/s 9 of the Insolvency and Bankruptcy Code, 2016 (The Code) based on the application filed by an operational creditor of the Company. Mr. Navin Khandewal IP No. 188/19/001/1P-007/2017-18/1301 was appointed as an Interim Resolution Professional (IRP) to manage affairs of the Company in accordance with the provision of Code. Pursuant to the NCLT order for commencement of the CIRP and in line with the provision of the Code, the power of the Board of Directors stand suspended and exercised by the IRP. Subsequently, Mr. Navin Kumar Sood IP No. 188/19/001/1P-007/2017-18/10274 in place of Mr. Navin Khandewal IP No. 188/19/001/1P-007/2017-18/1301 has been appointed as IRP vide NCLT order no. 14/12/IND/2021 in CP(19) 9 of 2020 dated 28<sup>th</sup> January, 2021. Therefore the above results were reviewed by the Management and the IRP. These financial results for the year ended 30<sup>th</sup> June 2021 have been prepared by the management of the Company in accordance with Regulation 32(2) of the SEBI (Listing Obligations and Disclosure Requirements) Rules, 2015. These unaudited financial results were placed before the IRP on 13<sup>th</sup> August 2021 for their consideration. Accordingly, the unaudited financial results were considered and recommended in the meeting. In view thereof, the IRP in reliance of such representations, clarification and explanation provided by the Management has approved the same. To the extent, these unaudited financial results indicate or confirm of events prior to the appointment of the Resolution Professional i.e CIRP commencement date, the confirmation is being provided by the Management. The resolution professional is relying on the management representation for all information and confirmation in relation to the day to day functioning of the Company. The IRP has approved these unaudited financial results only to the limited extent of discharging the powers of the Board of Directors of the company (suspended during CIRP) which has been conferred upon him in terms of provisions of Section 17 of the Code. (2) In accordance with the Code, public announcement was made calling the financial and operational creditors of the Company to submit their claims with IRP. Accordingly, IRP will collate the claims submitted by the creditors and reconcile the same with the accounts. Till the final outcome of CIRP process, no accounting impact in the books of accounts has been made for an excess, short or non-receipt of claims for operational and financial creditors. (3) The carrying value of property plant and equipment and intangible as at 30<sup>th</sup> June, 2021 is Rs. 14,667.03 lacs and 9.53 lacs respectively. As explained in note 1 above, the Company is under CIRP and IRP is required to invite submission of resolution plans from potential resolution applicants, which shall be put up for necessary approvals before the Committee of Creditors (CoC) and the NCLT. The CIRP is not yet concluded and the final outcome is not known. The Company has not taken in consideration any impact on the value of the asset, if any, in preparation Financial Results as required by IND AS 10 on "Event after the Reporting Period". The Company has not made assessment of impairment as required by IND AS 36 on Impairment of Assets, if any as at 30<sup>th</sup> June, 2021 in the value of property plant and equipment and intangible assets. (4) The SARS-CoV-2 virus responsible for COVID-19 outbreak, which has been declared a global pandemic by the World Health Organization, continues to spread across the globe and India and has contributed to a significant decline in economic activities and severely impacted the business and operations of the Company. The extent to which the COVID-19 pandemic will impact the Company's results will depend on future developments, which are highly uncertain. The Company has assessed the possible impact of COVID-19 pandemic on the business. As on the current date, based on the assessment, the Company has concluded that the impact of COVID-19 pandemic is not material on the carrying value of the assets of the business, however this has effected the operations of the company and has had impact on sales and profitability among others. As Covid-19 is unprecedented and the full recovery is still not in sight thus the exact effect of Covid - 19 on company financials can't be ascertained now. (5) The Company has not been able to obtain confirmations from various debtors, loans and advances from, trade and other payables on account of ongoing lockdown situation resulting from the COVID-19 pandemic. Accordingly, adjustments if any arising out of reconciliation with these parties is not readily available. The Company has carried out its internal assessment and accordingly provided written off back certain receivables/payables/ loans and advances. (6) During the quarter the Company has provided an interest amounting to Rs. 179.81 Lacs as per sanction letter stipulation, however the bank has not provided the same. Therefore, there exists a difference with regards to interest amount as per balance confirmation provided by the banks and books of accounts. (7) Renewable Energy Certificates of Rs. 1,173 Lacs is subject to adjudication of pending litigation at Apex Court the management is hopeful of realising the amount considering the legal opinion. (8) The Company has received order in relation

उसके विध्यांचल पर्वत की हरी भरी पहाड़ियों के मध्य जल प्रपात, कल कल बहती नदियों के साथ ही चहुँओर हरियाली की चादर ओढ़े टोटी बड़ी पहाड़ियां व खाई सैलावियों को बरबस अपनी और खिंच रही है। लिहाजा शनिवार के बाद संडे व स्वतंत्रता दिवस वीकेंड पर पाताल पानी के साथ ही अन्य पिकनिक स्थानों पर बड़ी संख्या में पर्यटक आए और प्राकृतिक सौंदर्य

से मनमोहित हुए। इस दौरान चोरल नदी, चोरल डेम, शीतला माता फाल, मेहंदी व बार्मानिया कुंड, जोगी भड़क, जाम गेट के साथ ही अन्य पर्यटन स्थलों पर सुबह से देर शाम तक सैलानी आते जाते रहे। पाताल पानी, चोरल नदी, जाम गेट आदि स्थानों पर तो शाम के समय पैर रखने की जगह तक नहीं दिखाई दे रही थी।

**NOTES:** (1) The National Company Law Tribunal (NCLT) Indore Bench at Ahmedabad vide order dated 17th September 2020 (Insolvency Commencement Date) has initiated Corporate Insolvency Resolution Process (CIRP) u/s 9 of the Insolvency and Bankruptcy Code, 2016 (The Code) based on the application filed by a operational creditor of the Company, Mr. Navin Khandewal IP No. IBBI/PA-001/IP-P00703/2017-18/11301 was appointed as an Interim Resolution Professional (IRP) to manage affairs of the Company in accordance with the provision of Code. Pursuant to the NCLT order for commencement of the CIRP and in line with the provision of the Code, the power of the Board of Directors stand suspended and exercised by the IRP. Subsequently, Mr. Naveen Kumar Sood IP No. IBBI/PA-001/IP-P00132/2017-18/10274 in place of Mr. Navin Khandewal IP No. IBBI/PA-001/IP-P00703/2017 has been appointed as RP vide NCLT order no. IA/12/IND/2021 in CP/IB) 9 of 2020 dated 28th January, 2021.

The above results were reviewed by the Management and the RP. These financial results for the year ended 30th June 2021 have been prepared by the management of the Company in accordance with Regulation 33(2) of the SEBI (Listing Obligations and Disclosure Requirements) Rules, 2015. These unaudited financial results were placed before the RP on 13th August 2021 for their consideration. Accordingly, the unaudited financial results were considered and recommended in the meeting. In view thereof, the RP in reliance of such representations, clarification and explanation provided by the Management has approved the same. To the extent, these unaudited financial results indicate or confirm of events prior to the appointment of the Resolution Professional i.e. CIRP commencement date, the confirmation is being provided by the Management. The resolution professional is relying on the management representation for all information and confirmation in relation to the day to day functioning of the Company. The RP has approved these unaudited financial results only to the limited extent of discharging the powers of the Board of Directors of the company (suspended during CIRP) which has been conferred upon him in terms of provisions of Section 17 of the Code. (2) In accordance with the Code, public announcement was made calling the financial and operational creditors of the Company to submit their claims with RP Accordingly, RP will call the claims submitted by the creditors and reconcile the same with the accounts. Till the final outcome of CIRP process, no accounting impact in the books of accounts has been made for an excess, short or non-receipt of claims for operational and financial creditors. (3) The carrying value of property plant and equipment and intangible as at 30th June, 2021 is Rs. 14,667.03 lacs and 9.53 lacs respectively. As explained in note 1 above, the Company is under CIRP and RP is required to invite submission of resolution plans to potential resolution applicants, which shall be put up for necessary approvals before the Committee of Creditors ("CoC") and the NCLT. The CIRP is not yet concluded and hence, the final outcome is not known. The Company has not taken in consideration any value of the asset, if any, in preparation of Financial Results as required by IND AS 10 "Event after the Reporting Period". The Company has not made assessment of impairment as required by IND AS 36 on Impairment of Assets, if any as at 30th June, 2021 in the value of property plant and equipment and intangible assets. (4) The SARS-CoV-2 virus responsible for COVID-19 outbreak, which has been declared a global pandemic by the World Health Organization, continues to spread across the globe and India and has contributed to a significant decline in economic activities and severely impacted the business and operations of the Company. The extent to which the COVID-19 pandemic will impact the Company's results will depend on future developments, which are highly uncertain. The Company has assessed the possible effects that may arise from the COVID-19 pandemic on the business. As on the current date, based on the assessment, the Company has concluded that the impact of COVID-19 pandemic is not material on the carrying value of the assets of the business, however this has effected the operations of the company and has had impact on sales and profitability among others. As Covid - 19 is unprecedented and the full recovery is still not in sight thus the exact effect of Covid - 19 on company financials can't be ascertained now. (5) The Company has not been able to obtain confirmations from various debtors, loans and advances from, trade and other payables on account of ongoing lockdown situation resulting from the Covid?19 pandemic. Accordingly, adjustments if any arising out of reconciliation with these parties is not readily available. The Company has carried out its internal assessment and accordingly provided written off/ back certain receivables/ payables/ loans and advances. (6) During the quarter the company has provided an interest amounting to Rs. 173.91 Lacs as per the sanction letter stipulation, however the bank has not provided the same. Therefore, there exists a difference with regards to aforesaid amount as per balance confirmation provided by the banks and books of accounts. (7) Renewable Energy Certificates of Rs. 1,173 Lacs is subject to adjudication of pending litigation at Apex Court the management is hopeful of receiving the amount considering the legal opinion. (8) The Company has received order in relation to Service Tax matter from, Principle Commissioner CGST & Central excise vide order no. 04-05/COMMR/ST/IND/2021/6073 dated 26th March, 2021 received on 3rd April, 2021 related to Valuation method for calculation of Service Tax. Approx demand in order is Rs. 8,798 Lacs plus interest. The Service Tax department has lodged the claim before the RP. The same has been rejected by RP. Thereafter, the department has filed an appeal in NCLT, the matter is pending with NCLT. (9) Figures of the previous periods have been regrouped and reclassified where ever necessary and feasible, in order to make them comparable.
