स्टार बना दिया जहां वह एक ही पैरालम्पिक में दो पदक (10 मीटर एयर राइफल स्वर्ण और 50 मीटर राइफल थ्री पोजिंशंस कांस्य) जीतने वाली पहली भारतीय महिला बनी। पद्मश्री और खेलरत्न से नवाजी

जा चुकी 22 वर्ष की इस खिलाड़ी ने कहा, मैं एक समय पर एक ही टूर्नामेंट के बारे में सोचती हूँ। मैं अतीत के कीर्तिमानों के बारे में सोचने की बजाय वर्तमान में जीती हूँ। इस साल की सारी बड़ी स्पर्धाओं खत्म हो चुकी है और अब पूरा फोकस पेरिस पर है। उन्होंने कहा, मैं पेरिस में कई स्पर्धाओं में उतरूंगी। पदक को लेकर कयास नहीं लगा सकती लेकिन इतना ही चाहती हूँ कि जब बाहर निकलूँ तो यह कह सकूँ कि मैंने अपना सर्वश्रेष्ठ किया। अपने अभ्यास के तरीके में भी वह बदलाव करने के पक्ष में नहीं है लेकिन गलतियों से सबक लेकर बेहतर प्रदर्शन पर पूरा ध्यान है। उन्होंने कहा, अभ्यास का तरीका वही है क्योंकि इसी से मुझे सफलता मिली है। मैं अपनी ताकत पर

पाकिस्तान के पूर्व कप्तान मोईन खान के बेटे आजम पर दो दिन पहले पीसीबी मेच रेफरी ने मेच फीस का 50 प्रतिशत जुर्माना लगाया था क्योंकि उन्होंने अपने बल्ले से फलस्तीन के झंडे का स्टीकर हटाने से इनकार कर दिया था। आजम मेच के दौरान अंपायर के निर्देशों का पालन करने में बार-बार विफल रहे।

यह पीसीबी के खिलाड़ियों और खिलाड़ियों के सहायक कार्मिक के लिए आचार संहिता के अनुच्छेद 2.4 का उल्लंघन है। पीसीबी ने जुर्माना पूरी तरह से माफ करने का कोई कारण नहीं बताया। बोर्ड ने इस बारे में भी कोई जानकारी नहीं दी कि आजम आगामी मैचों में अपने बल्ले से स्टीकर हटाने के लिए सहमत हुए हैं या नहीं।
