- 1. The Board of Directors of the Company at its meeting held on August 01, 2019 has appointed me as a Scrutinizer for conducting the postal ballot voting process.
- 2. I submit my report as under:
- 2.1 The Company has completed on August 22, 2019, the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared in the Register of Members/list of beneficiaries as on August 20, 2019. The company has also made arrangement for e-voting with CDSL.
- 2.2 Particulars of all the postal ballot and e-voting forms received from the Members have been entered in a register separately maintained for the purpose.
- 2.3 The postal ballot forms were kept under, Company's safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 2.4 The ballot boxes were opened on September 24, 2019 in my presence.
- 2.5 The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company/ list of beneficiaries as on August 20, 2019
- 2.6 All postal ballot forms received up to the close of working hours on September 24, 2019, the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny.
- 2.7 Envelopes containing postal ballot forms received after September 24, 2019 were not considered for my scrutiny.



- 2.8 Envelopes containing postal ballot forms returned undelivered aggregated to 137 vide serial number 1to 137. These envelopes were also not opened and they are separately kept.
