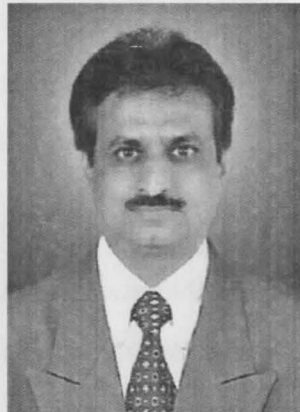
On promotion as Deputy General Manager, he will be acting as National Head – Large & Mid-Corporate advances at Credit Marketing Department, Head Office.

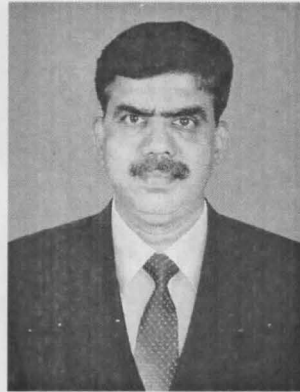
On promotion as Deputy General Manager, he will be the Head of Bengaluru Region of the Bank.

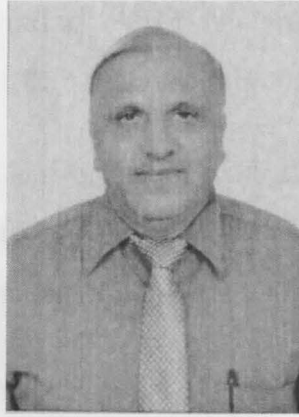
On promotion as Deputy General Manager, she will be the Head of Centralised Loan Sanctioning Centre [CLSC] at Mangaluru.
