Further to our disclosure dated 6th February 2024 we have to inform you that One-Up Financial Consultants Pvt. Ltd holds shares of Cineline India Limited, which shares are listed on your Stock Exchange.

In this regard kindly note that we, along with person acting in concert, have sold net 575,402 shares (bought 56112 shares & sold 631514 shares; gross 687,626 shares) of the company from November 30, 2022 to February 5, 2024. As a result of the above mentioned sale, the shareholding of One-Up Financial Consultants Pvt. Ltd. along with persons acting in concert has fallen by 1.6792% (Gross transactions 2.0067%; Net sale 1.6792%) to 4.4431% of the paid-up capital of the Company.
