We wish to inform you that on 7th April, 2020, we have intimated about creation of pledge on 8,12,62,921 (i.e.10.54%) Units of Embassy Office Parks REIT (“**REIT Units**”) in favour Catalyst Trusteeship Limited (“**Catalyst**”), Debenture Trustee to secure redeemable, rated, listed, secured, tradable, principal protected, market linked non-convertible debentures (“**NCDs**”) aggregating to Rs.1355 crores issued by the Company.


As per the terms of agreements executed with NCD holders and Catalyst, the Company has to transfer 8,12,62,921 REIT units from existing Demat account to our new Demat account, after release of pledge by Catalyst in two tranches i.e. in first tranche, 4,00,00,000 REIT Units and in second tranche, 4,12,62,921 REIT Units.

After completion of transfer of above said REIT units in tranches to our new Demat account, the Company has to create pledge in favour of Catalyst in two tranches as mentioned above. Transfer and creation of pledge on first tranche, i.e 4,00,00,000 REIT Units has been completed on 23rd April, 2020.

In view of the above and with reference to the disclosures required to be made by Embassy Property Developments Private Limited (the “**Pledgor**”) to Embassy Office Parks Management Services Private Limited (the “**REIT Manager**”) in relation to the release of pledge on 4,12,62,921 REIT units by Catalyst on 24th April, 2020. 
