Please be informed that the material unlisted subsidiary company of Indiabulls Housing Finance Limited ("the Company"), namely, Indiabulls Commercial Credit Limited ("ICCL") has received the no objection letter ("NOC") from the Reserve Bank of India ("RBI") for the proposed change in its name to "Sammaan Finance Limited". The Company has already filed the application for such conversion of CoR with RBI. The approval from shareholders to the proposed change in its name is already in place.
