नवी दिल्ली, दि.११ : दिल्लीत सार्वजनिक बसमध्ये महिलांना मोफत प्रवासाचे गिफ्ट दिल्यानंतर आता केजरीवाल सरकारने आणखी एक महत्वपूर्ण निर्णय घेतला आहे. त्यानुसार, आता दिल्लीतील सरकारी राग्णालयांमध्ये व्हीआयपी संस्कृती बंद करण्यात येणार आहे. त्यामुळे यापुढे कोणत्याही व्हीआयपी व्यक्तीला सरकारी राग्णालयांमध्ये प्रायव्हेट राम मिळणार नाही, अशी घोषणा दिल्लीचे मुख्यमंत्री अरविंद केजरीवाल यांनी ट्रिटद्वारे केली आहे.
