- The remote e-voting period has commenced from, Friday 03<sup>rd</sup> November 2023 at 9.00 A.M. (IST) and ended on Saturday, 02<sup>nd</sup> December 2023 at 5.00 P.M. (IST) and the remote e-voting module was disabled thereafter.
- For the purpose of remote e-voting facility to be provided to its members, the company has availed the services of Central Depository Services (India) Limited ("CDSL")
