A proposal for revision in the remuneration of M/s. B S R & Co. LLP, Chartered Accountants, Gurugram was placed before the Audit committee meeting held on August 06, 2020. The Audit Committee discussed the matter and after due deliberation the Committee reached at a conclusion that the proposal regarding proposed increase in the remuneration of the Statutory Auditors is exorbitant and the company cannot afford such increase in such a sort span and moreover Company recently began with revival of its business operations after setbacks due to Covid-19 and considering the post demerger & listing of shares any such increase in cost would



be a suicidal step for future growth of the company. Hence, the proposal was declined by the Audit Committee and was not recommended to the Board of Directors. The same was intimated to the Auditors and to the Management. Thereafter, the Statutory Auditors tendered their resignation resulting in Casual vacancy.
