Pursuant to the provisions of Regulation 30 of SEBI Listing Regulations, we write you to inform that the Board of Directors ("Board") of JHS Svendgaard Laboratories Limited ("Company") at its meeting held today i.e. August 14, 2023, analysed and discussed the proposal for consolidation of business of the Company and Vedic Cosmeceuticals Private Limited ("VCPL").

The Company is engaged in manufacturing and selling (Exports) of Toothbrushes, Toothpastes, Mouthwash, Denture Tablets and other allied Oral care Products. On the other hand, VCPL is engaged in developing, manufacturing and selling of skincare products for Baby care, Hair Care, Body Care, Intimate Care, Pet care, Spa Products and Grooming products.
