Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that the Company has received an Order from the Office of the Joint Commissioner State-Tax, Patliputra Circle, Patna Commercial Taxes Department, Bihar, demanding tax of Rs.0.50 crore, interest of Rs.0.38 crore and penalty of Rs.0.05 crore under Section 73 of Central Goods and Services Tax Act, 2017 and Bihar Goods and Services Tax Act, 2017 for the financial year 2019-20 for disallowance of input tax credit claimed by the Company. The Company is in the process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.
