Sub: Report of Scrutinizer on Postal Ballot

I, Mohit Gurjar, Partner of M/s. P S Rao & Associates, Practicing Company Secretaries, having office at Flat No. 10, 4th Floor, Ishwarya Nilayam, Dwarakapuri Colony, Punjagutta, Hyderabad- 500082 had been appointed as the Scrutinizer to conduct the postal ballot process in respect of the following Special Resolutions pursuant to the Notice dated October 28, 2020 issued under Section 110 and other applicable provisions of the Companies Act, 2013 ('the Act') read with the Companies (Management and Administration), Rules, 2014, as amended.

- i. Approval of "Balaji Amines Limited Employee Stock Option Plan 2020" (ESOP2020)
- ii. Approval of grant of employee stock options by way of secondary acquisition under "Balaji Amines Limited Employee Stock Option Plan - 2020" (ESOP 2020)
- iii. Approval for Provisioning of money by the Company to the Balaji Amines Limited Employees Welfare Trust / Trustees for purchase of its own shares by the trust / trustee for the benefit of employees under the Balaji Amines Limited Employees Stock Option Plan-2020

The notice dated October 28, 2020 along with statement setting out material facts under Section 102 of the Act, as confirmed by the Company, were sent to the shareholders in respect of the above mentioned resolutions proposed through Postal Ballot.

In compliance with the requirements MCA Circular dated 8th April, 2020, MCA Circular dated 15th June, 2020 and MCA Circular dated 28th September, 2020, hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business envelope were not dispatched to the shareholders and they were sent only through email as per relaxations provided in the MCA circulars. The shareholders were required to communicate their assent or dissent through the remote e-voting system only.

The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting e-voting by the Shareholders of the Company.

The shareholders of the company holding shares as on the "cut-off" date of November 06, 2020 were entitled to vote on the resolutions as contained in the Notice.

The voting period for remote e-voting commenced on Friday, 13th November, 2020 at 09:00 a.m.(1ST) and ended on Sunday, 13th December, 2020 at 05:00 p.m. (1ST) and the NSDL e-voting module was disabled thereafter.

We have scrutinized and reviewed the remote e-voting based on the data downloaded from the NSDL e-voting system and maintained register in which necessary entries have been made in accordance with the Companies (Management and Administration) Rules, 2014 as amended.

My responsibility as scrutinizer for the remote e-voting is restricted to making a Scrutinizers Report of the votes cast in favour or against the resolutions.
