We at the outset regret for the inconvenience caused to you in this regard.

In continuation of our earlier letter dt.29th May, 2024 attaching the Standalone Audited Financial Results for the year ended 31st March, 2024 alongwith Independent Auditors Report, Cash Flow Statement, Statement of assets and liabilities, we would like to state that we had inadvertently missed to add declaration of unmodified opinion/statement of Impact of Audit Qualification to the Financial Results.

We hereby submit the following declaration of Unmodified Opinion by the Auditor and the same can be taken as part of the Financial Results already submitted to the Stock Exchange on 29th May, 2023.

Declaration of Unmodified Opinion

It had been a difficult year as the operations of the Company were still affected due to insufficient business orders. The prices of the raw materials had increased particularly Gold and Radium whose prices had sky rocketed but the Company could not pass on the proportionate increase in prices to the end consumer.

In this context, we wish to inform you that there is no qualification in the Audit Report. There is just a declaration regarding Material Uncertainty related to Going Concern and the Auditors opinion is not qualified in respect of this matter.
