BRIEF PROCEEDINGS OF 04TH ANNUAL GENERAL MEETING OF HEALTHY LIFE AGRITEC LIMITED HELD ON SATURDAY, 30TH SEPTEMBER, 2023 AT 11:00 A.M. THROUGH VIDEO CONFERENCING ("VC") / OTHER AUDIO VISUAL MEANS ("OAVM")

Ms. Jyoti Kukreja, Company Secretary and Compliance Officer welcomed all Members, Directors and other invitees to the 04th Annual General Meeting (AGM) of the members of Healthy Life Agritec Limited ('the Company') held on Saturday, 30th September, 2023 at 11:00 a.m. IST through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM").

All the Directors of the Company attended the meeting. It was informed that the meeting was held through Video Conferencing VC / OAVM without the physical presence of the members at a common venue in accordance with the various Circulars issued by Ministry of Corporate Affairs.
