2,000 रुपए के नोट लाने, वापस लेने से भारतीय मुद्रा की स्थिरता पर संदेह पैदा हुआ: चिदंबरम

मुंबई, (भाषा)। कांग्रेस के वरिष्ठ नेता पी चिदंबरम ने सोमवार को कहा कि 2,000 रुपये का नोट जारी करने और बाद में इसे वापस लेने से भारतीय मुद्रा की अखंडता और स्थिरता पर संदेह पैदा हुआ है। पूर्व केंद्रीय वित्त मंत्री ने यहां एक संवाददाता सम्मेलन में कहा कि प्रमुख आर्थिक संकेतक नीचे की ओर इशारा कर रहे हैं और इस बात का भरोसा कम है कि अर्थव्यवस्था उच्च वृद्धि के रास्ते पर पहुंच जाएगी। उन्होंने यह भी कहा कि मणिपुर की स्थिति खतरनाक है और इस पर प्रधानमंत्री नरेंद्र मोदी की लगातार चुप्पी से सवाल उठते हैं। मणिपुर में जातीय संघर्षों में 75 से अधिक लोगों की जान चली गई है। चिदंबरम ने कहा कि इससे भी बुरी बात यह है कि सरकार अपनी गलतियों को सुधारने की कोशिश भी नहीं करती है। भारतीय रिजर्व बैंक ने हाल ही में 2000 रुपये के नोटों को चलन से वापस लेने की घोषणा की थी और लोगों से इसे 30 सितंबर तक बैंकों में जमा करने या बदलने के लिए कहा। चिदंबरम ने कहा, 2000 रुपये के नोट की

देश में कोरोना के 310 नए मामले आए सामने

नई दिल्ली, (विभा)। देश में कोविड-19 के 310 नए मामले सामने आए हैं जबकि उपचारार्थ मरीजों की संख्या 4,972 से घटकर 4,709 हो गई है। केंद्रीय स्वास्थ्य मंत्रालय के सोमवार सुबह आठ बजे जारी अद्यतन आंकड़ों के अनुसार संक्रमण से दो लोगों की मृत्यु होने से मृतक संख्या बढ़कर 5,31,866 हो गई है। मंत्रालय ने बताया कि संक्रमितों की संख्या 4.49 करोड़ (4,49,90,054) दर्ज की गई। उपचारार्थ मरीजों की संख्या कुल संक्रमितों का 0.01 प्रतिशत है जबकि कोविड-19 से ठीक होने की संख्या बढ़कर 4,44,53,479 हो गई है और मृत्यु दर 1.18 प्रतिशत हो गई है। मंत्रालय की वेबसाइट के अनुसार, राष्ट्रव्यापी टीकाकरण अभियान के तहत देश में कोविड-19 रोधी टीके की अब तक 220.66 करोड़ खुराक दी जा चुकी है।
