National TT player Manika drops match-fixing bomb

Alleges coach Roy asked her to throw match in qualifiers

New Delhi, Sept 4: Table tennis star Manika Batra has alleged that national coach Soumyadeep Roy asked her to throw a match during the Olympic qualifiers in March and that was the main reason she refused his help in the singles competition of the Tokyo Games.

Responding to Table Tennis Federation of India's show cause notice, Manika strongly denied that she brought disrepute to the game by refusing Roy's help.

According to TTFI sources, the world number 56 stated she would not have been able to focus on her match if someone who asked to her indulge in match-fixing months earlier was sitting by her side.

"Besides the need to avoid disturbance due to his last minute



intervention, there was an additional and much more serious reason behind my preference to play without the national coach," the Khel Ratna awardee alleged in her response to TTFI secretary Arun Banerjee.

"The national coach had pressurised me during the qualification tournament in Doha in March 2021 to concede my match to his student to enable her to qualify for Olympics - in short- to indulge in

match-fixing," she said. Despite repeated attempts, Roy was not available for a response to the allegations. The player-turned coach has also not been asked to join the ongoing national camp and has been told by TTFI to present his side of the story.

"The allegations are against Roy. Let him respond and then we will decide future course of action," said Banerjee when asked about

Manika's response to the showcause notice.

Roy is a former Commonwealth Games gold-medallist in the team event and also an Arjuna awardee.

Both Manika and Sutirtha Mukherjee, who train in Roy's academy, ended up qualifying for the Tokyo Olympics. Manika qualified on her higher world ranking after losing to Sutirtha, who secured the Olympic quota from the event held in Doha.

"I have evidence of this incident and I am ready to present it to the competent authorities at the appropriate time. For asking me to concede the match, the national coach personally met me in my hotel room and talked to me for nearly 20 minutes," said Manika.

Pramod, Suhās enter badminton finals; Manoj, Tarun lose

Tokyo, Sept 4: Indian shuttlers Pramod Bhagat and Suhās Yathiraj on Saturday stormed into the men's singles finals of the badminton event in their respective classification but Manoj Sarkar's hopes came crashing after he suffered a loss in his SL3 class semifinal at the Tokyo Paralympics here. Tarun Dhillon also lost his semifinal 16-21, 21-16, 18-21 against Lucas Mazur of France.

The 33-year-old Pramod, the current world no 1, secured a 21-11, 21-16 win over Japan's Daisuke Fujihara in the first SL3 class semifinals that lasted 36 minutes.

The top seeded Indian, current World and Asian champion, will clash with Great Britain's Daniel

Bethell in the summit clash later in the day.

In SL4 class, Suhās outwitted Indonesia's Fredy Setiawan 21-9, 21-15 in 31 minutes in the first semifinal.

The Noida District Magistrate will face top seed Lucas Mazur of France in the summit clash on Sunday.

Manoj will now play Fujihara in the bronze medal play-off. With only half of the court being used in this classification, Bhagat and Fujihara engaged in a lot of long rallies and the Indian came up on top most of the time.

Pramod, the top seed, lagged 2-4 early in the opening game but a series of overhead drops helped him claw back. The duo was 8-8 before the Indian entered

the interval at 11-8.

After the break, he continued his good run and eventually pocketed the opening game with six straight points.

It was a Pramod show in the second game as well as the Indian led all the way to come up trumps.

Pramod will pair up with Palak Kohli for their mixed doubles SL3-SU5 semifinals later in the day.

"It was a great game against Fujihara, he pushed me with some great shots. But I had a plan and I executed it very well. I am happy I have reached my maiden Paralympic finals but the work is not done yet," said Pramod after his match.

Harvinder wins first ever Paralympic archery bronze

Credits family, support staff on 'Olympian' feat

Tokyo, Sept 4: Harvinder Singh on Friday notched up India's first ever archery medal in the Paralympics, holding his nerves to down Kim Min Su of Korea in a thrilling shoot-off for the men's individual recurve bronze in the ongoing Games here.

The feat could not have been sweeter as the win came against Korea - India's known nemesis in the sport - as the world No. 23 held his nerves to down Kim Min Su in a thrilling shoot-off for



the individual bronze in the recurve men's open section.

"Obviously they're an archery powerhouse and have been dominant against us. The key was

not to let him dominate. It really paid off," Singh, who won the shoot-off with a perfect 10 against Kim's 8, said in a virtual press conference.

On a day his fancied teammate Vivek Chikara, who finished in top-10 in the rankings round, made a last-16 exit, Singh won the bronze playoff 6-5 (26-24, 27-29, 28-25, 25-25, 26-27) (10-8) "I may have won the medal but behind the scenes many have worked for it. My coaches, family, support staff, SAI had a big role to play in achieving this feat. It's a team effort," the 31-year-old said.

India has sent a team to each Paralympic Games since 1984 but it was in Rio 2016 Games that an athlete - Pooja - competed in the para archery event.

World No.23 Singh was also the first athlete from India to win a gold medal at a major para competition in the 2018 Asian Games.

An economics scholar from the Punjabi University, Patiala, Singh collected three shoot-off

wins on the day starting with his triumphs in the opening rounds.

In the bronze play-off, the 31-year-old was leading 5-3 before the Korean clinched the fifth set shooting a perfect 10 to force a shoot-off where the Indian responded in style shooting a perfect 10 against Kim's 8.

In the semifinals, Singh lost to world number 10 Kevin Mather of the USA 6-4 in an intense five-setter (25-28, 24-24, 25-25, 25-24, 24-26).

"I was really disappointed after losing the semifinal, I could have easily won that. So I wanted to give it all in the bronze match. I had nothing to lose," he said.

Singh, who hails from a small village Guhla Cheeka near Kaithal in Haryana, was stretched to the fullest in the first two rounds, but he showed tremendous resilience to overcome his fancied opponents via shoot-offs.

Many years ago while reading the book, Silas Marner by George Eliot, I remember the way one of the characters, Molly dies in a snow storm. With that she lies in the snow and dies.

I read this book, first as a teenager, and often wondered how the snow suddenly became a seductive, inviting bed for her: Initially she was fighting the blizzard, but the fight became difficult as the snow grew higher and she finally laid down and died.

Dying looked so inviting.

Very often in the earlier part of my life, I travelled in the local trains of the city, second class. Sometimes I jumped last into the bogie and found myself hanging out of the door. I do remember on more than one occasion, the ache in my arms grew so unbearable, all I wanted was to let go the bar.

The thought of letting go felt so

sweet! I could actually feel my arms begging me to do so.

How like self-pity this is!

We go through situations, trying and difficult. We fight the challenges, we stand up to the storm, but as days go by and the battle doesn't abate we grow weary, both mentally and physically. Suddenly all we want to do is to lie down and cry.

All Molly in Silas Marner wanted to do was to lie in the snow and die. She did.

All I wanted to do in the train was to let go and fall.

How sweet the feeling of giving up. It is over! We feel sad, dejected, we dig into our pockets, into our minds and swallow the opium of self-pity, sink deeper and deeper into despair and into the doldrums of the cunning inviting snow.

Self-pity is a refuge that is sometimes most appealing. "Oh you poor man," she whispers to the man who stands up to some tyranny in his office or housing colony, "Let me embrace you!"

It's a fatal embrace, one that strangles us to death.

Is it worth giving ourselves up to this momentary relief?

"Hold tighter!" I used to urge myself as my tired arms begged me to let go, and I shudder to think what would have happened if I'd given up, maybe maimed, maybe dead?

Hold on, plod on; ignore the inviting snow, the opium in your pocket, the self pity in your mind, and steadfastly push on till you reach your goal.

Nobody has regretted fighting the snow storm and living to tell the tale..!

Agitated Osaka loses to new entrant, smacks racket

New York, Sept 4: Naomi Osaka smacked her racket against Arthur Ashe Stadium's court. Moments later, she chucked her equipment, sending it bouncing and skidding halfway to the net. Then came a full-on spike near the baseline.

Osaka's game was off. Her composure was gone. By the end, the crowd was booing her for taking too much time between points, turning her back to the court.

Soon enough, Osaka's title defense at the US Open was over in the third round with a 7-5, 6-7 (2-7), 4-6 loss Friday night to Leylah Fernandez, an 18-year-old from Canada who is ranked 73rd and never had been this far in Grand Slam competition.

Osaka? She came in with a 16-match winning streak at majors and four career trophies, all on hard courts. But this was Osaka's first Slam tournament since she pulled out of the French Open before the second round to take a mental health break she also sat out Wimbledon, before participating in the Tokyo Olympics, where she lit the cauldron and maybe the time off was an issue.

Another possible factor in her failure to close things out while serving for the victory against the left-hander Fernandez at 6-5 in the second set: Osaka hadn't competed since Monday. That's because the woman she was supposed to meet in the second round, Olga Danilovic, withdrew because she was sick.

Osaka, who left the court after seven games to change outfits and put on a highlighter-yellow dress, was quite good down the stretch in the opening set. She grabbed 12 of the last 13 points, including the last nine,

with a break at love to go up 6-5, and a hold at love with the help of a pair of aces at 112 mph and 114 mph to end it.

Seemed on track for a similar conclusion in the second set, leading 6-5 and serving. But when she sailed a forehand wide, Fernandez had her first break of the match to make it 6-all.

And so began Osaka's downward spiral. She fell behind 0-5 in the ensuing tiebreaker, missing shots and displaying her frustration as she occasionally has done in the past by flinging her racket.
