# Kejriwal walks out...

Many thanks to everyone," Kejriwal's wife Sunita, who was filling in for her husband during his absence from the electoral battleground, said in a post on X in Hindi. Kejriwal's release from jail, however transient, is expected to give a boost to the AAP's Lok Sabha campaign in Delhi where polling is scheduled for May 25, with its foremost leader hitting the hustings. While imposing a string of bail conditions on Kejriwal, the apex court directed him to furnish bail bonds of Rs 50,000 with one surety of the like amount to the satisfaction of the jail superintendent. A bench of Justices Sanjiv Khanna and Dipankar Datta rejected the vehement argument of the Enforcement Directorate (ED) counsel that enlarging Kejriwal on interim bail to campaign in the elections will be without a precedent. The court did not concur with his contention that interim bail to the AAP national convenor for campaigning would be like giving "premium of placing the politicians in a benefic position compared to ordinary citizens of this country". The bench said no doubt, serious accusations have been made, but Kejriwal has not been convicted yet, does not have any criminal antecedents and is "not a threat to the society". It noted that more importantly, the legality and validity of his arrest itself was under challenge before the top court which is yet to finally pronounce its verdict on it. "The factual situation cannot be compared with harvesting of crops or plea to look after business affairs. In this background, once the matter is subjudice and the questions relating to legality of arrest are under consideration, a more holistic and libertarian view is justified, in the background that the 18th Lok Sabha General Elections are being held," the bench said.

### 'Will purify Ram...

Pramod Krishnam, who quit the grand old party recently over its anti-Sanatan stand also slammed Nana Patole for insulting and derogatory remarks. "This is an absurd and ridiculous statement. By taking Lord Ram's name, one becomes pure. All our sins get washed away by taking his name. What does Congress want to say by purification?," Krishnam asked. He also advised the Congress to first get rid of their hatred against Lord Ram before talking about purification. "If Congress pursues such rhetoric, this will spell doom for the party," he added.

# 12 Naxals killed...

Union Home Minister Amit Shah congratulated the security forces for the encounter operation in Chhattisgarh in which 29 Naxalites were killed and said that the government is determined to free the country of this

Shah said that naxalism is the biggest enemy of development, peace and bright future of youth.

# Palestine: India votes...

It recommended that the Security Council "reconsider the matter favourably, in the light of this determination". India was the first non-Arab State to recognise the Palestine Liberation Organisation as the sole and legitimate representative of the Palestinian people in 1974. India was also one of the first countries to recognise the State of Palestine in 1988 and in 1996, Delhi opened its Representative Office to the Palestine Authority in Gaza, which was later shifted to Ramallah in 2003. Earlier this month, India's Permanent Representative to the UN Ambassador Ruchira Kamboj had said that while Palestine's application for membership at the UN was not approved by the Security Council because of the veto in the UNSC, "I would like to state here at the very outset that in keeping with India's long-standing position, we hope that this would be reconsidered in due course and that Palestine's endeavour to become a member of the United Nations will get endorsed".

An annex to the resolution said that the additional rights and privileges of participation of the State of Palestine will be effective as of the 79th session of the General Assembly that begins in September this year

The Supreme Court on Friday issued notice on a plea filed by Tamil Nadu minister Udhayanidhi Stalin seeking directions to consolidate various FIRs and complaints lodged against him over his controversial statements on 'Sanatan

Dharm'. Agreeing to examine the plea, a bench presided over by Justice Khanna

Sanjiv sought responses from various state governments in the matter. On April 1, the Bench, also comprising Justice Dipankar Datta, had granted time to bring all the subsequent events by way of filing an application seeking amendment in the petition.

The petition highlighted that except for one com-

## **RESERVOIR LEVELS FURTHER PLUNGE TO 15 PC**

# **Southern India grapples** with severe water scarcity

With the southern region most hit at just 15 per cent total live storage capacity in reservoirs, the storage capacity this year is below the average of last 10 years during the corresponding period, the Central Water Commission (CWC) data has revealed.

The CWC's analysis also indicated a week-on-week decrease in storage levels, affecting not only the southern region but also the nation as a whole.

As of last Thursday, the southern region's reservoir capacity stood at 16 per cent, dropping from 17



per cent the previous week.

The bulletin from the CWC said the southern region has been severely impacted, with reservoirs operating at only 15 per cent of their total live storage capacity.

Nationally, out of 150

the CWC shows that storage levels this year are lower than both the corresponding period last year and the ten-year average for the

■he data from

monitored reservoirs, the total live storage capacity is 178.784 billion cubic metres (BCM), approximately 69.35 per cent of the estimated 257.812 BCM created across the country. However, the live storage

available in these reservoirs currently sits at 27 per cent recorded last year and 32 per cent on average over the past decade.

Compared with historical data, the bulletin highlights that the current live storage is only 79 per cent of last year's levels and 92 per cent of the 10-year average for the corresponding period.

The storage during the current year is lower than that of the corresponding period last year in all of the country while it is below the average storage of the last 10 years during the corresponding period in northern, eastern southern and western.
