## HIGHLIGHTS OF RESTRUCTURING PLAN (RP) SANCTIONED BY BANKERS:

- Cutoff date 1<sup>st</sup> January, 2018
- Total Debt as on cut-off date is Rs.590 crs.
- After implementation of RP the total debt will split into sustainable debt amounting to Rs.360 crs. & unsustainable debt amounting to Rs.230 crs.
- The unsustainable debt of Rs.230 crs. will be converted into CRPS
- CRPS will be redeemed in five equal installments from 2028-29 to 2032-33.
- Sustainable repayable debt will be repaid up to 31st March, 2028.
- The Interest rate on sustainable debt will be reduced from current 12% PA to 9.05% PA.

Disclaimer: The restructuring plan is sanctioned by the all Bankers, but implementation of the same can happen after members approval in this AGM, infusion of funds by investors and revalidation / amendments of the sanction letter from Bankers.
