The 17<sup>th</sup> Annual General Meeting of the Company was held on Friday, 29<sup>th</sup> September, 2023 at 11.00 a.m. through video conferencing mode and the venue of the meeting was deemed to be the registered office of the company situated at J-41, MIDC Ambad, Nashik, Maharashtra-422010.

Mr. Mukund Narayan Kulkarni, Chairman and Managing Director of the Company conducted the proceedings of the meeting and welcomed the members present at the 17<sup>th</sup> Annual General Meeting of the Company through Video Conferencing.
