नई दिल्ली, 25 जून (भाषा)।

भारतीय आयुर्विज्ञान अनुसंधान परिषद (आईसीएमआर) के महानिदेशक डॉ बलराम भार्गव ने शुक्रवार को कहा कि गर्भवती महिलाओं को कोविड-19 का टीका लगाया जा सकता है, लेकिन बच्चों को यह टीका लगाने के विषय पर फैसला करने के लिए और अधिक आंकड़ों की जरूरत होगी। भार्गव ने संवाददाता सम्मेलन के दौरान कहा कि स्वास्थ्य मंत्रालय ने यह दिशानिर्देश दिया है कि वे

(कोविड के टीके) गर्भवती महिलाओं को लगा सकते हैं। हमने अपने आईसीएमआर प्रैगकोविड रजिस्ट्री से यह भी प्रदर्शित किया है कि टीकाकरण गर्भवती महिलाओं के लिए उपयोगी है और यह दिया जाना चाहिए। दरअसल, आईसीएमआर प्रमुख से बच्चों और महिलाओं के टीकाकरण पर एक सवाल किया गया था।

भार्गव ने कहा कि पर्याप्त आंकड़े उपलब्ध होने तक बच्चों को कोविड-19 की खुराक दिया जाना अब भी चर्चा का विषय है।
