### Subject: Consolidated Scrutinizer's Report for Remote E-voting and Electronic Voting at the 56<sup>th</sup> Annual General meeting (AGM) of the Company held on Monday, 28<sup>th</sup> September, 2020

The Board of Directors of the Company at its meeting held on 29.06.2020 had appointed me as Scrutinizer for remote e-voting and also for electronic voting at the AGM in respect of below mentioned resolutions proposed at the 56<sup>th</sup> AGM of the company held on Monday, 28<sup>th</sup> September, 2020 at 3.00 p.m.(IST) through video conferencing/ other audio visual means.

Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company has confirmed that the notice convening the 56<sup>th</sup> AGM of the company along with the instructions for the remote e-voting and electronic voting at the AGM and the annual report for the financial year 2019-20 were sent through electronic mode to those members whose e-mail addresses were registered with the company/Depository Participant(s) for communication purposes in compliance with MCA Circular dated 5<sup>th</sup> May, 2020 read with Circulars dated 8<sup>th</sup> April, 2020 and 13<sup>th</sup> April, 2020(collectively referred to as 'MCA Circulars') and SEBI circular dated 12<sup>th</sup> May, 2020.

The Company has published a notice in this regard in Business Standard (news paper in English) and Desh Sewak (newspaper in Punjabi) on 04.09.2020.

Pursuant to Section 108 of the Act read with the Rules and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Company has provided remote e-voting facility and also electronic voting facility at the AGM to its members in respect of business to be transacted at AGM.

The Company had appointed Central Depository Services Limited (CDSL) as the service provider, for the facility of Remote e-voting as well as electronic voting facility at the AGM to those members of the company who had not cast their vote through remote e-voting.

On completion of electronic voting at the AGM, the results of the remote evoting and electronic voting by members at the AGM, on the CDSL e-voting platform were unblocked by me, downloaded and diligently scrutinized.
