Dear Sir/Madam,

We write in connection with above subject.

We confirm having complied with following points from SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 and Advisory letter No. SEBI/HO/MIRSD/PoD-1/OW/P/2023/17664 dated April 28, 2023 on Common and simplified norms for processing investor's service requests by RTAs and norms for furnishing PAN, KYC details and Nomination:

Point no.17 – *'RTAs shall provide a certificate of compliance from a practicing Company Secretary, within 30 days from the date of this circular coming into effect, certifying the changes carried out, systems put in place / new operating procedures implemented etc. to comply with the provisions of this circular.'*

As per the Circular, we have submitted Compliance Certificate issued by Practising Company Secretaries to SEBI on 29/5/2023.

Point no.18 – *'Listed Companies/RTAs shall submit a report to SEBI by May 31, 2023, on the steps, taken by them towards sensitizing their security holders regarding mandatory furnishing of PAN, KYC and nomination details as detailed in para 4 of this circular.'*

As per the Circular, we have submitted our Compliance Report to SEBI on 31/5/2023.
