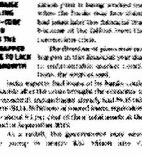
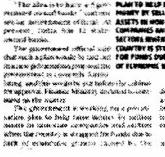
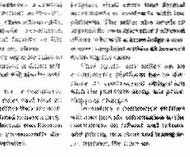

The new Consumer Protection Act, 2019, which came into force on July 1, 2019, has introduced several changes to the existing Consumer Protection Act, 1930.
