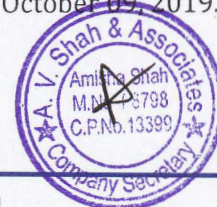

Shah & Associates, Practicing Company Secretaries, Mumbai was appointed Scrutinizer, by the Hon'ble National Company Law Tribunal, Mumbai Bench ('NCLT'), by its Order dated the September 27, 2019 to conduct and scrutinize voting process in a fair and transparent manner and present report on voting through Postal Ballot and voting through Poll/Ballot Paper at the venue of the meeting of the Sundry Creditors of Sundaram Multi Pap Limited held on Tuesday, November 12, 2019 at 3.30 p.m., at the registered office of the Company at 5/6, Papa Industrial Estate, Suren Road, Andheri East, Mumbai: 400093, Maharashtra for seeking approval of Sundry Creditors to the proposed Scheme of Amalgamation of E-Class Education System Limited with Sundaram Multi Pap Limited in terms of Notice dated October 07, 2019 convening the meeting.

I hereby submit my report as under:

Notices were issued to Sundry Creditors whose name were appearing in the Statutory Auditors Certificate certifying the list of Sundry Creditors of the Company as on June 30, 2019 and voting rights were reckoned as on June 30, 2019, being cut-off date for the purpose of deciding the entitlement of Sundry Creditors to vote at the meeting.

As confirmed by the Company and as per dispatch proofs available, the Notice dated October 07, 2019 convening the meeting of the Sundry Creditors of the Company along with relevant annexures, setting out material facts under sections 230-232 and 102 of the Companies Act, 2013 read with Rule 6 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016, in respect of the resolution to be passed at the meeting was sent to the Sundry Creditors on or before October 09, 2019.



The Company has published the Notice of the said meeting along with instruction for voting in "The Free Press Journal" (In English) and "Navshakti" (In Marathi) of October 10, 2019.

Company has provided facility of Voting by Postal Ballot & Voting through Poll/Ballot Paper at the venue of the Meeting.

The voting by the Sundry Creditors through the Postal Ballot commenced at October 13, 2019 at 11:00 am and ended on November 11, 2019 at 5.00 pm.

The meeting was attended either in person or by proxy or by Authorized Representative by 2 Sundry Creditors of the Company.

The Chairman of the meeting, at the end of the discussion on the day of the NCLT convened meeting of Sundry Creditors, i.e. November 12, 2019, allowed the voting through Poll/Ballot paper for all those Sundry Creditors who were present at the meeting but had not cast their vote by postal ballot.

Company had obtained necessary authorization from the Sundry Creditors who has voted through Postal Ballot or who has attended the meeting.
