Sub: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Update on Restoration of Soda Ash Production

With Reference to our earlier communication dated June 14, 2023, and in compliance with Regulation 30(4) read with Para B of Part A of Schedule III to the SEBI (LODR) Regulations, 2015 and other applicable provisions, if any, we hereby provide update on mechanical breakdown of CO₂ gas compressor in our Soda Ash Plant.

We are pleased to inform that the mechanical breakdown of the CO₂ gas compressor has been temporarily addressed and the production of Soda Ash has been restored to 75% of the normal capacity.

We took immediate action to address the Compressor break-down so as to take care of the production loss at the plant. As a stop gap arrangement, we had sent the Compressor parts for repair and have successfully re-started the plant with 75% capacity. Additionally, we have ordered a new set of compressor parts (4 months' supply lead time) to replace in the existing Compressor and expect installation & restoration of 100% production by end of September 2023.
